Technical Specification for Four Ball EP Test Apparatus

The details of the technical specifications are given below:

- **1. Standard Test Specification Details:** The instrument must meet to standard specifications -ASTM D 2783, D 2596, D 2266, D 4172, D 5183, IP 239, IP 300 and related specifications.
- 2. Model Details and Requirements: A suitable PC based model should contain electronically controlled test speed and temperature. The instrument should perform Wear Preventive (WP) and Extreme Pressure (EP) tests. The design of the instrument should be very compact with digital display of applied load, torque, time, speed, temperature and no. of revolutions accumulated during the test. All necessary components of the instrument should be provided.
- **3. Software:** The Instrument should contain user friendly software for applications and compatible with all units. Software should be able to set & control the operating conditions of the instrument and explore the analytical data i.e. coefficient of friction, graphical relation between frictional torque and normal load and other necessary data. Software must be able to evaluate the necessary test parameter of standard specifications being followed. Software must be compatible with latest window operating system and should be upgradable to advance version upto next five years (Instrument suppliers should provide the upgrades free of cost).
- **4. CCD Camera:** CCD camera with video card and wear scar analysis software should be provided for wear scar imaging and measurement. The resolution of CCD camera should be with 0.1 mm wear scar legible capacity.
- **5. Test Speed**: Operational test speed of the instrument should be from 100 to 3000 rpm and Test Speeds: 1200, 1440, 1760 rpm should be adjustable. The instrument should automatically shut off on seizure.
- 6. Load Capacity: Maximum axial load capacity of the instrument should be: 10000 N at 2000 rpm or 12000 N at 1800 rpm.

- **7. Test Duration:** Time measurement capacity of the instrument should be from 1 second to 999 minutes or more.
- 8. Test Ball Diameter: The test balls should be made from chrome alloy steel of AISI standard steel no. E-52100. The diameter of test balls should be of 0.5 in. (12.7 mm) with grade 25 EP (extra polish). The Rockwell C hardness of balls should be 64 to 66.
- **9. Operating Temperature Range**: The operational temperature range of the instrument should be from ambient to 100 °C.
- **10.Standard Lubricating Oil Sample:** Standard lubricating oil with known values of parameters as per methods must be provided as a reference for calibrating the instrument as well as for demonstration purpose at the time of installation and commissioning .
- **11.Safety aspect of the Instrument:** The instrument must be safe to operate. Any error/ diagnostics display when any failure of unit occurs must be built in the system software.
- **12.Supply of PC:** Necessary PC required for the instrument must be provided along with the instrument and as integral part of instrument it must be considered as part of guarantee/warrantee/AMC along with the instrument.

- **20.
