ANNEXURE - "A"

General Terms and Conditions for Third Party Inspection Services

1. SCOPE OF WORK

Scope of the tender shall cover carrying out stage wise & final inspection of raw materials and fabricated items such as fabricated columns, beams, rafters, steel sheeting etc. and other associated bought-out items for PEB Warehouse of floor area approximately 3100 sq. mtr and eave height of 11.5 mtr at vendor's works located at 8th Km Stone, Sampla Kharkhoda Road, Village Hassangrah, Distt. Rohtak, Haryana-124404

Proper coordination shall be carried out with our vendor for stage-wise testing/inspection of the materials and finished items strictly as per the Quality Assurance Plan enclosed as **Attachment-I.**

The bidder shall asses the no of visits required to complete the entire job and quote accordingly. However, a minimum of **14 (Fourteen)** visits shall be considered within the scope.

The scope of work of bidder will include but not limited to the followings -

- 1.1. Verification of raw material including material traceability, check testing
- 1.2. Verification of bought out items such as welding consumables etc including review of test certificates
- 1.3. Verification of equipment and facility of welding and relative activity
- 1.4. Review of Welding Procedure Specification w.r.t. construction code and project requirement
- 1.5. Review of NDT procedure
- 1.6. Witness of Procedure Qualification Record
- 1.7. Witness of welder qualification
- 1.8. Validation of JIG and fixture
- 1.9. Fitment inspection
- 1.10. In process inspection of welding
- 1.11. Final inspection of welding including NDT (UT and PT)
- 1.12. Final dimensional inspection including assembly
- 1.13. Review of painting procedure
- 1.14. Verification of Surface Preparation
- 1.15. Inspection of DFT of paint stage wise and final paint

2. COMPLETION PERIOD

The selected Inspecting Agency has to carry out inspection of materials in phased manner based on the inspection call issued by our vendor. Our vendor is expected to complete the job of supply of materials for the PEB Warehouse within next 5 months i.e. by June 2017.

The inspection work is solely linked with the progress of works of our vendor. Within the completion period, a minimum of **14 (Fourteen)** visits shall be made for completion of the entire inspection job.

3. EARNEST MONEY DEPOSIT

The Bid should be accompanied by a Demand Draft of Rs 3,000 (Rupees Three Thousand only) towards earnest money deposit (EMD) issued by any scheduled bank drawn in favour of M/s Balmer Lawrie & Co. Ltd. payable at Kolkata. EMD of unsuccessful bidders will be refunded after finalization of order. EMD of successful/shortlisted bidder will be refunded after completion of the scope of work.

Earnest Money deposit (EMD) is exempted for bidders registered under NSIC or coming under the definition of Micro and Small Industries and holding valid registration certificates covering the tendered items/services. However, attested/Notarized copy of valid NSIC certificate or "Micro and Small" industry certificate must be submitted along with the tender. The certificate must cover the scope/supply/services for which the Tender is invited.

4. PAYMENT TERMS

No advance payment will be made. Payment shall be made prorata basis as certified by our Engineer-in-Charge on completion of stage wise inspection as per the scope of work.

5. ADDRESS FOR SUBMISSION OF HARD COPIES OF THE TENDER
