## TERMS AND CONDITION

1. The term “**Company (or) BL**” wherever mentioned in the tender document refers to “**BALMER LAWRIE & CO. LTD.**”
2. The term “**bidder**” means the firm or company with whom the order is placed and shall be deemed to include the bidder, successors, representatives, heirs, executors and administrators duly approved by the company.
3. **Period of Contract:** From **APRIL 2017** to **MARCH 2018**.  
However, as per tender terms, on mutual agreement with the successful bidder the company shall **extend the contract period / till exhausting the balance order quantity whichever is later**.
4. The quantity mentioned in the tender is based on estimation only and not committed. Further if required, the company shall make **quantity swap among items** within the contract value awarded to successful bidder to meet the requirement during tenure of contract in case exigency.
5. The offer shall be submitted in our enquiry format only and any conditional offers will not be accepted.
6. **SECURITY DEPOSIT (SD):** On award of contract, the successful bidder will be has to submit SD for **Rs.5,000/-** (Rupees **Five Thousand** only) by Demand Draft form any Nationalized / Scheduled Bank within 15days from the date of receipt of intimation from the company.
  - a. The SD shall bear no interest and shall be refunded only on expiry of contract period by Cheque only.
  - b. All sums of compensation [or] other sums of money payable by the successful bidder may be deducted from the SD.
  - c. **SD is liable to forfeiture in the event of –**
    - i. Withdrawal of order during validity period of the contract.
    - ii. If the service of the successful bidder is found to be unsatisfactory and fails to adhere to our tender terms and conditions, the SD will be forfeited.
    - iii. Any unilateral revision made by the successful bidder during the validity period of the contract.
7. The offer must be kept valid for a minimum period of **60 Days from** the date of opening the offer.
8. The rate quoted by the successful bidder shall remain valid during the tenure of the contract period, no rate increase will be considered, except for change in statutory levies imposed by Union / State Govt. / Local authorities.
9. Payment: **30 days from the date of completion of work**.
10. **Penalty Clause:** Any failure on the part of the successful bidder to carry out the job as per company's schedule, required quantity, quality etc. will be viewed seriously. Further, the company reserves the right to execute the job at the then prevailing market rates and the additional cost if any incurred in this process will be recovered from the successful bidder. Also the successful bidder may be debarred from participating in future tenders of the company.
11. The bids of any bidder may be rejected if a conflict of interest between the bidder and the Company is detected at any stage.
12. Late tenders / delayed tenders including postal delay and those not conforming to the prescribed terms and conditions will not be considered at all.
13. The company would not carry out any negotiations except with such bidders who is / are the lowest quoted bidders originally. As such it would be in the interest of the bidders to quote the lowest possible rate.
14. It shall be understood that every endeavor has been made to avoid error which may materially affect the basis of the tender and the successful bidder will take upon himself to provide for risk of any error which may subsequently be discovered and shall make no subsequent claim on account thereof.
15. **Safety:** Our division is under certification for EMS:14001 / OHSAS System and hence the bidders are required to ensure that all their workmen are adhering to the safety norms as prescribed in Environment Management System –EMS.
16. **ARBITRATION:** Any dispute or difference arising under this Contract shall be referred under jurisdiction of Chennai to a sole arbitrator to be appointed by the Chairman & Managing Director, Balmer Lawrie & Co. Limited and the provisions of Arbitration and Conciliation Act, 1996 including any statutory modifications or enactment thereof shall apply to the Arbitration proceedings. The fees of the arbitrator, if any, shall be shared equally by both the parties. The award shall be a speaking award stating reason therefor and is final and binding on the parties. The proceeding shall be conducted in English language and courts at Chennai will have exclusive jurisdiction to settle any dispute arising out of this contract.
