General Terms and Conditions :

1. The transporter should place vehicle at loading point as per our requirement. In the event of their failure to do so, the company reserves the right to impose penal charges @Rs 1000/-per day per vehicle for delay in placement.
2. The driver should carry necessary documents including RC Book, tax receipt, insurance policy of the vehicle, driving licence, identity cards etc.
3. In case of failure of the contractor to place required vehicles on time/arrange transportation. BL reserves the right to utilize the services of any other transporter without notice at the risk and cost of the contractor and to recover charges and expenses in excess of the contractual obligations, the work shall be completed at the risk of the contractor and cost through alternative source /arrangements. This will be without prejudice to the right of BL for any other action including termination
4. Payment would be made on satisfactory completion of the work. Bills for transportation shall be accompanied by acknowledge delivery challans, confirming the receipt of consignments by the consignees/customers in good condition and without any loss/physical damage to the cargo. Bills will not be accepted by us for payment without the consignee's acknowledgement in the delivery challans.
5. Payment after deduction of TDS as per rules would be made by cheque within 30 days from the date of receipt of bills
6. The transporter should specify service tax is applicable with their registration number and the rate.
7. Detention charges, if any, beyond 24 hrs. at the unloading point to be specifically mentioned.
8. Only the lowest quoted (L1) transporter will be awarded the contract. However, the company has the discretion of awarding the contract to more than one transporter. The decision of the company is final in retaining more than one transporter.
9. The successful tenderer shall not be allowed to sub-let either wholly or any part of the order without the Company's prior written consent.
