1.0 PROCEDURE FOR BID SUBMISSION

The Tender Document is comprising of Notice Inviting Tender and Price Schedule – I in a single bid system. The submission of offer can be made in two forms through e-bidding or in physical form as follows:

1.1 BID SUBMISSION THROUGH E-BIDDING

The bidder shall submit their response through bid submission to the tender on e-Procurement platform at https://balmerlawrie.eproc.in by following the procedure given below. The bidder would be required to register on the e-procurement market place https://balmerlawrie.eproc.in and submit their bids on line. The bidders shall submit offer comprising Notice Inviting Tender and Price Schedule I in the standard formats displayed in e-Procurement web site. The bidders shall download the Tender Document, scan the NIT and uploading the same duly stamped and signed, in the e-Procurement web site. Bidders should submit their Price Bids in the prescribed e-format available in BL e-procurement site.

M/s. Balmer Lawrie & Co. Ltd. (BL) invites offers in prescribed form either through on-line or offline from competent and experienced parties with sound financial capabilities for providing a non-AC Car for Balmer Lawrie's site personnel to commute between transit accommodation to IOCL Gujarat Refinery, Jawaharnagar, Vadodara as per following terms and conditions:

(1) Type of Vehicle:

Non A/c. diesel car — suitable for accommodating minimum of 4 persons.

(2) Area of Travel

Car will generally ply between Balmer Lawrie's transit accommodation to Gujarat Refinery, Jawaharnagar, entire Vadodara, nearest Railway Station, Bus stand, Airport and adjacent areas as per our requirements. The car should move inside the Refinery premises with proper permission as per our requirement.

(3) Scope:

- (i) Providing road worthy vehicle (Indica or equivalent car) with valid and relevant statutory documents as required to ply inside the Refinery and the area specified in sl. no. 2 above. Car should report to our site personnel at the transit accommodation and to other predetermined locations, as informed by our officers every day.
- (ii) The car should be provided with experienced driver.
- (iii) Maintenance charges, fuel etc. will be borne by the bidder
- (iv) All necessary documents required for making the gate passes for car & the driver will have to be provided for entry into the Refinery as and when required.

- (v) The driver should have valid license, ESI & PF papers and any other statutory documents required for obtaining gate passes.
- (vi) A detailed logbook is to be maintained by the driver and this is to be signed every time this car is used by Balmer Lawrie personnel.
- (v) Suitable alternative arrangement should be made by the bidder, if the car is not available due to maintenance or any other problem.

(4) Pre-Qualifications

Bidders should fulfill the following prequalification criteria and copies of same should be submitted along with their offers:

- (ii) Service Tax Registration for `Rent a Cab"
- (ii) Car should not be more than 4 years' old.
- (i) Car should have commercial licence.
- 12 hours/day. However, the time may increase during our plant operation in two shifts except Sundays/National Holidays.

(6) Period of hiring

12 (twelve) months from the date of work order. However, duration of hiring may be extended for another year at the same rate and other terms & conditions. Since Balmer Lawir's work at IOCL Gujarat Refinery may not be on continuous basis for which there will not be any usage of car, hiring charges during idle period of more than 1 (one) month will not be paid.

(7) Price Basis:

Bidder to quote on the basis of

- Lumpsum all-inclusive charge per month for 17 hours per day and plying upto 3000 Km per month.
- (ii) Hourly rate for duty beyond 17 hours in a day.
- (iii) Rate per Km beyond the initial 3000 Km/month.
- (iv) Payment of Service Tax will be as per Statute.

- (v) Toll tax will be reimbursed at actuals on submission of receipts along with your bill.
- (vi) The vendor must commence the car services within seven days from the date of placement of order and the hiring period will be reckoned from the date of usage.
- (vii) KM and time will be calculated from Balmer Transit Accommodation to Refinery worksite and not from Gurage to Gurage.

(8) Arbitration

Any dispute or difference arising out of the contract/agreement shall be referred for adjudication to a Sole Arbitrator to be appointed jointly by both the parties in terms of Arbitration and Conciliation At 1996 (as amended). Arbitration proceedings shall be conducted in English language and place of arbitration will be Kolkata. The Arbitrator so appointed with pass a speaking award which will be binding on both the parties. Cost of Arbitration will be shared equally between the parties, unless agreed otherwise.

(9) Service Tax

Service Tax will be as per statute. Bidder should not mention Service Tax component in the tender.

(10) Payment of Driver's wages

The car driver/s' should have bank account and wages/salary will have be paid by direct remittance to his bank account. As copy of such remittance should be attached with monthly RA bill.

(11) Payment Terms:

Against monthly bill duly certified by BL's site-incharge. Photocopy of the relevant pages of the log-book duly certified by BL should be attached with monthly bill.

(12) Earnest Money Deposit(EMD)

Bid should be accompanied with a bank draft of Rs.10,000/- (Rupees Ten Thousand only) toward EMD drawn in favour of "Balmer Lawrie & Co. Ltd." payable at Kolkata. EMD of successful bidder will be converted into interest free Security Deposit till completion of project and released upon expiry/termination of contract.

(13) Validity:

Offer shall be valid for 90 days from the due date of enquiry.

(14) Penalty

Alternate arrangement must be made on the day when regular car is not available due to break down, repair work or any other reason. Failure to provide alternate vehicle, will attract proportionate deduction from the RA bill. Deduction will be based on KM running of that particular month and working days whichever is higher.
