- 1.2 Bidders not meeting the above requirements shall be rejected. Pre-qualification of the bidders shall not imply final acceptance of the tender. The bids may be rejected at any point during techno-commercial evaluation or during price evaluation. The decision in regards to acceptance and/or rejection or offers any/all offers in part/full shall be at the sole discretion of Balmer Lawrie & Co. 2.0 Delivery

- 2.1 The jeweler would be required to deliver the Silver Salver at Kolkata, Delhi, Mumbai and Chennai Offices of the Company.
- 2.2 The delivery shall be within fifteen days from the date of placement of order.

3.0 Price rejection for delayed delivery
