Penalty Clause (For delay beyond contract period upto 15 days from LOI/PO)

As such the Bidder must ensure removal of all allocated scrap from our factory and organize to keep our yard and the factory premises clean of said scrap. In the event of failure to do so, the buyer /contractor is liable to pay the penalty towards the following.

- Finance cost for holding inventory or scrap i.e., value of the scrap @ 24% p.a.
- Warehousing charges on daily basis @Rs. 5/-per sq.ft per day.

Other terms to be noted:

Parties should lift the material from our factory on **as is where is basis**. When you bring trucks, you have to come with the workmen for shifting the materials and loading the truck manually. All workmen shall have insurance coverage under Workmen Compensation Act or ESI/PF Coverage. All the statutory requirements as below should be available when you bring vehicle for loading scrap items at our plant. Vehicles without valid documents as below will not be allowed inside our premises and scraps shall not be loaded to such vehicles which are not complying the requirement. **RC / FC / Insurance / Driving Licence / Emission Certificates etc and all other statutory requirements as applicable for the vehicle, driver and cleaner if any.**

The available materials may be inspected on any working day between 10:00 AM to 4:30 PM. Contact Person: Mr. Gopi- 04425946574. Your offer shall be for all the items. If the tenderer is not quoting for all the items, their offer will be disqualified.

Materials will be offered on **AS IS WHERE IS BASIS** and no rejection of material is allowed. If any offer is found with condition for not accepting leaky barrels etc, it will be rejected.
