4. Submission of Tender Documents:

- > The tenderers are requested to carefully study all the tender documents and tender conditions before quoting their rates.
- > The tender must be strictly in accordance with the terms and conditions and specifications laid out in the tender.
- Any terms and conditions given by the tenderer in their offers will not be binding on Balmer Lawrie.
- The sole proprietor or authorised representative shall sign all documents that need to be enclosed with tender document. SCOPE OF WORK

PART A - RODENT CONTROL SERVICES

The 'scope of work' shall inter alia comprise the following areas in providing Rodent Control Services:

- 1. Total and effective control of rodents, e.g. rats, mice, etc. with the help of Advanced Rodent Management Techniques.
- 2. Use of Baiting, Trapping & Proofing methods with selective use of chemicals/pesticides wherever necessary.
- 3. Use of Glue Boards/Traps etc. as a part of rodent pest management operations wherever necessary.
- 4. Rodent Control Treatment as per requirement.
- 5. Application of Sanitation and Rodent Proofing measures from time to time to prevent the rodent entry in the premises.
- 6. The items/products/chemicals used shall be safe/unharmful to human contacts.

PART B - DISINFECTION SERVICE IN ADMINISTRATION BUILDING AND OTHER BUILDINGS CONTROL OF COCKROACHES AND ANTS

Purpose: To out-line a procedure for control of cockroaches and ants.

Procedure:

- 1. Gel Baiting is done against cockroaches and spraying is done against ants on (Mention Frequency) months for Admin office and monthly for Canteens.
- 2. Gel is applied as very small spots in infested areas.
- 3. Deltramethrin is sprayed targeting ant colonies.
- 4. Handling and spraying is done in such a way that there is no body contact with insecticides.
- 5. Protective equipment are used.
- 6. Applicator is used to apply Gel.
- 7. Spraying equipment is used for spraying.

Frequency of rodent treatment / disinfection:

Qualified Service Technicians shall visit our premises at least twice in a month and also as and when required to control rodents/Disinfection.

PART - C - SMOKE TREATMENT FOR MOSQUITO

To control Mosquito in the entire **premises** through Smoke Treatment. The Fogging Machine should be used in all open & closed drains and also in areas mentioned in Annexure-B. The frequency of such smoke treatment shall be communicated by the company from time to time.

Coverage of Area:

Location for Rodent Control, Disinfection and Mosquito Treatment (Part A, Part B & Part C) is given in detail, in "Annexure - B".

GENERAL TERMS AND CONDITIONS

1. Eligibility Criteria For Techno-Commercial Bid

- a) Payment of Interest Free EMD of Rs 3,000/-
- b) Bidder should be register vendor with Balmer Lawrie & Co Ltd Container Freight Station, Dronagiri, Navi Mumbai or any other unit of Balmer Lawrie & Co. Ltd.
- c) The agency needs to furnish the declaration that they are not black listed by any PSU/Government bodies in past.

2. Submission Of Bids

The bids should be submitted in single bid process i.e. Technical / Commercial Bid [Unpriced] bid with Price bid. For Price Bid, only the rates are to be submitted as per given format.

3. Tender Opening

Unprice and price bid will be opened as per tender calendar.

4. Acceptance of offers

- 4.1 Balmer Lawrie reserves the right to accept any tender in whole or in part or reject any tender or all tenders or place order for any quantity, less than or more than the tendered quantity, without assigning any reason thereof.
- 4.2 Bids of any tenderer may be rejected if a conflict of interest is detected between the bidders and Balmer Lawrie at any stage.
- 4.3-Balmer Lawrie is not bound to accept the lowest rate for any tender. Balmer Lawrie also reserves its right to allow Public Enterprises (Central / State) price / purchase / contract / service preference as admissible under the existing Government policy. The decision of Balmer Lawrie in this connection will be final.
- 4.4 Incomplete tenders, conditional tenders, tenders received late or tender not conforming to the terms and conditions mentioned in the Tender documents or not accompanied by the requisite Earnest Money Deposit (unless exempted under the terms of this Tender) will be rejected.

5. Negotiations

- 4.1 Balmer Lawrie reserves the right to negotiate with the Tenderer. Tenderer will have to attend the concerned office of Balmer Lawrie for negotiations/clarifications required from them, in respect of their quotations, without any commitment on the part of Balmer Lawrie.
- 4.2 In case of negotiation, the Tenderer should send the confirmation of outcome of such negotiation in writing so as to reach the concerned office of Balmer Lawrie within 3 days from the date of negotiation/ the time stipulated. If the Tenderer fails to comply with this requirement Balmer Lawrie reserves its right to ignore their quotation at its discretion with the attendant remedies available to them.

6. Price Variation

- 6.1 The price should be firm and irrevocable and not subject to any change whatsoever even due to increase in cost of materials, components and labour cost till the validity of the contract period.
- 6.2 The offer shall be valid for a period of minimum 60 days from the date of opening the price Bid.

7. Notification Of Award

Prior to the expiry period of Bid validity, BL will place purchase order or letter of indent on the successful bidder(s).

8. Contract Period

The contract will be for a period of **[12 months effective from date of issue of WO /LOI]** or such date as may be mutually agreed. On satisfactory performance during the initial contract period of **[12 months]**, the contract may be extended as mutually agreed for another period of one year on the existing terms & conditions.

9. Security Deposit / EMD

The Earnest Money Deposit of Rs 3,000/- of the successful bidders will be converted into Non-interest bearing Security Deposit (SD) and shall be retained till completion of the contract/extended contract period. In the event of non-performance of the contract, the security deposit will be forfeited and the contractor will be blacklisted for future tenderers. EMD of unsuccessful bidders will be returned after finalization of the contract.

10. Payment Terms

Payment will be released within 7 (seven) days from the date of submission of monthly invoice after due certification by our authorized official in the following month.

11. Sub-letting of Work

No part of the contract or any share or interest therein shall in any manner or degree be transferred, assigned or sublet by the contractor directly or indirectly to any person, firm or corporation without the consent in writing from Balmer Lawrie. In the event of contractor contravening the conditions, Balmer Lawrie shall be entitled to get the work done from other firm at the 'Risk & Cost' of the contract.

12.Safety and penalty

The Contractor will be penalized for any safety violation as follows of the contract . The decision of the Safety Committee headed by Safety Incharge will be final .Secondly for any safety violation viz. not using PPE as required by the nature of the job per violation Rs. 1000/- will be charged. If any major safety violation has been observed which resulted in any loss of property the cost will be debited on actual.

13. Indemnity

The Contractor will be required to indemnify and keep indemnified the Company against all losses and claims for injury and damage to any person or any property whatsoever which may arise out of or in consequence of the work and against all claims, demands proceedings damages, cost charges and expenses whatsoever. The company may forward the bidder any such claim demand or complaint made by any other person against the company. In such event, the contractor shall solely be liable for the disposal of the said complaint.

The contractor will be required to Indemnify and absolve the Company of all responsibilities related to employment condition of their employees and should adequately safeguard Company against any possible IR problems including those related to employment. The bidder should adhere to all State and Central Enactments related to employment such as Minimum Wages Act, Workmen Compensation Act, Provident Fund Act, Employees State Insurance Act, Gratuity Act, Bonus Act, Contract Labour [Regulations and Abolition] Act etc. Further, Company will not have any liability towards employment, remuneration or compensation in whatever manner made to the employee of the bidder. Such demand shall be settled by the bidder directly.

14. Termination

The contract can be terminated by either party by giving 3 (Three) months notice in writing. However in case of serious breach of contract by the Contractor the Company reserves the right to terminate the contract without notice.

15. Arbitration
