- On termination of the contract, the contractor will be required to hand over all instruments / lines in proper working condition irrespective of the mode of termination of the contract.
- ESI formalities are to be maintained, if applicable, without which no worker of the contractor will be allowed to work inside the premises.
- Safety and security of the system, equipment, tools and tackles, and material at site shall be solely the responsibility of the contractor during the contract period. The contractor shall take all necessary precaution to prevent wastage, damage or theft or loss whatsoever.
- 5 The contractor shall abide by the security regulation at site promulgated by the company from time to time.
- 6 The contractor at his own cost arrange for the safety provision stipulated by the Government or local authorities in respect of all laborers directly or indirectly employed for the performance of the work.
