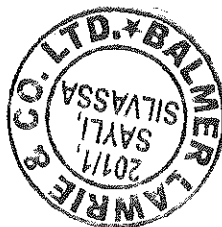

1.0.0 General Terms & Conditions

- 1.4.0 Selection & placement of offer:** Purchase order will be placed on a single **technically & commercially qualified vendor**, whose total price of entire supply **stands lowest**.
