






Annexure-I

Specification of Pallets

- 2 Way, Multiply use, newly manufactured. Double face, Non Reversible
- Good Quality Hard Pine Wood of properly finished without Knots and cracks.
- Size of each pallet should be : 48" x 52" x 6"
- Load Carrying Capacity of each 2 MT/Pallet
- Each pallet should be Forced Hot Air Treated [FHAT].Proof/Certificate has to be given during supply of each lot.
- The plank in pallet should have uniform width and all planks in each pallet should have same symmetry and finishing.
- Fastener [Block] should be annularly threaded nail of Fastener length 70 mm ,tread length 53 mm ,thread diameter 4.2 mm and total numbers in each pallet should be 72 nos.



Note

- Any deviation in quality during the supply would not be accepted and vendor has to uplift the rejected pallets within 7 Days from the date of intimation on his own cost. Replacement would be provided within 7 Days or payment would be deducted.
- Vendor has to provide one pallet as a free sample for our testing and evaluation purpose before starting the full supply. After the approval of sample, vendor would be asked for full supply.
