- 1. Dismantling the existing old Signage, if any, structure from the existing position of the BL distributor by cutting rusty bolts nuts etc. Complete Fabrication, Mounting and Installation of one SF GSB LED Backlit signage.
- 2. SF LED Backlit signage:
  - a. Size: Custamised as per the location (Average 24 square feet per location in no case vendor can exceed the regional budget allocated)
  - b. Quantity = 181 nos as per the List Annexure A2
  - c. Artwork as per the CD and approval of size / layout / design etc. to be taken from Sr. Manager (Brand).
- 3. **Standards:** The work has to be carried out in neat and tidy manner to the satisfaction of the Company's Inspection team and all care has to be taken to ensure that no part of the Distributor building gets damaged during execution of works.



### 2) Bid Qualifying Criteria:

- a) Bidder should be a Registered Vendor with BL.
- b) Submit order copy of two (02) PO executed in last 3 years of similar type of Job work (LED backlit signage) with BL or any other company of average value not less than
  - i) Rs. 4 Lacs if bidding for one region.
  - ii) Rs. 6 Lacs if bidding for two regions,
- c) The bidder has to be a Goods and Services Tax Network registered service provider. Submit copy of valid GST registration certificate and indicate GSTN Number.

#### 3) Financial Evaluation Process:

- b) L1 Bidder would be determined separately for each region considering total net outflow to the company.
