#### ANNEXURE – "A"

#### General Terms and Conditions for Third Party Inspection Services

#### 1. SCOPE OF SERVICE

Scope of the tender covers inspection of following equipment/machineries/items as per Purchase Order, technical Specification, approved drawings/BOM, approved Quality Assurance Plan etc. The inspections are mostly to be carried out at respective vendor's works. However, if required inspection shall also be carried out MMLH project site at Visakhapatnam, Andhra Pradesh.

## A) Package- Ammonia Based Industrial Refrigeration System for Temperature controlled Warehouse (TCW):

- i) Refrigeration Compressors
- ii) Air Cooling Units
- iii) Ammonia Pumps, Water Pumps
- iv) Evaporative Condensers
- v) Pressure Vessels such as HP Receiver, LP Receiver, Economizer, Priority Vessel
- vi) MCC Panel, PLC panels, instruments, controls
- vii) Any other equipment/items offered for inspection by the supplier.

#### 2. COMPLETION PERIOD

Inspection calls will be issued by our Supplier in 1-2 days in advance. The selected bidder shall attend the calls accordingly. All the inspections as covered in this tender will be completed within 4 (Four) months from the date of LOI/Order.

#### 3. EARNEST MONEY DEPOSIT

The Bid should be accompanied by a Demand Draft of **Rs 3,000 (Rupees Three Thousand only)** towards earnest money deposit (EMD) issued by any scheduled bank drawn in favour of M/s **Visakhapatnam Port logistics Park Ltd.** payable at Kolkata. EMD of unsuccessful bidders will be refunded after finalization of order. EMD of successful/shortlisted bidder will be refunded after completion of the scope of work.

Earnest Money deposit (EMD) is exempted for bidders registered under NSIC or coming under the definition of Micro and Small Industries and holding valid registration certificates covering the tendered items/services. However, attested/Notarized copy of valid NSIC certificate or "Micro and Small" industry certificate must be submitted along with the tender. The certificate must cover the scope/supply/services for which the Tender is invited.

#### 4. PAYMENT TERMS

No advance payment will be made. Payment shall be made prorata basis as certified by our Engineer-in-Charge on completion of inspection as per the scope of work.

#### 5. ADDRESS FOR SUBMISSION OF HARD COPIES OF THE TENDER
