- 1. Presently, at SBULC we have two powder blenders. The scope of work as given in **Annexure 2 page 1 & 2** of the tender document, applies for providing support services for Powder Blending work at both the blenders.
- 2. As mentioned in Annexure 2 page 1 & 2 of the tender document, the Shifting of raw materials/intermediates/additives, as and when required, within 1 km radius within factory premises including loading and unloading, for which charges to be incurred by the contractor. Also, packed/finished products are to be shifted and stacking should be done in the designated area by the contractor within the premises.
