#### General Terms and Conditions:

- 1. The transporter should place vehicle at loading point as per our requirement. In the event of their failure to do so, the company reserves the right to impose penal charges @Rs 1000/-per day per vehicle for delay in placement.
- 2. The driver should carry necessary documents including RC Book, tax receipt, insurance policy of the vehicle, driving license, identity cards etc.
- 3. In case of failure of the contractor to place required vehicles on time/arrange transportation. BL reserves the right to utilize the services of any other transporter without notice at the risk and cost of the contractor and to recover charges and expenses in excess of the contractual obligations, the work shall be completed at the risk of the contractor and cost through alternative source /arrangements. This will be without prejudice to the right of BL for any other action including termination.
- 4. Payment would be made within 30 days on satisfactory completion of the work and receipt of POD and Bill.
- 5. The transporter should specify GST is applicable with their registration number and the rate.
- 6. Detention charges, if any, beyond 24 hrs. at the unloading point to be specifically mentioned.
- 7. The rate as quoted shall be valid for a period of 3 month, it may be extended for further period of 3 months on mutual consent.
- 8. Only the lowest quoted (L1) transporter will be awarded the contract.

Any dispute or difference whatsoever arising between the parties out of or relating to the construction, interpretation, application, meaning, scope operation or effect of this contract or the validity of the breach thereof, shall be settled by arbitration in accordance with the rules of Arbitration of the "SCOPE Forum of Conciliation and Arbitration" and the award made in pursuance thereof shall be binding on the parties.

The award of the Arbitrator so appointed shall be final and conclusive and binding on all parties to the agreement subject to the Provisions of the Indian Arbitration Act 1940 and the rules there under and any statutory modifications or re-enactments thereof deemed to apply to the Arbitration proceeding under this clause.
