Delivery Schedule: Within 7-15 days to reach our G&L Silvassa factory from the date of Purchase Order/LOI

**Validity**: Your offer should be valid for our acceptance for a minimum period of 30 days from the due date unless specified otherwise.

Payment terms: 30 days from date of receipt of material.

**Acceptance of Offer**: BL reserves the right to reject any / all tenders if a conflict of interest between bidder and BL is detected at any stage
