- 3) All the offers shall be valid for a period of 180 days from the date of closing of e-Auction. In case bids are not confirmed by Balmer Lawrie& Co. Ltd. within stipulated period, bidders have option to take refund of EMD/Security or may take the delivery of cargo.
- 4) All the materials are offered for sale on AS IS WHERE IS basis, Ex- works owners and where they are stacked. The Principal/Owner will not be bound to assign any reason or details thereof. Value of the materials so withdrawn, if any, and paid by the buyer will be refunded without any interest. The Principal will however, not be responsible for any damage, loss, direct or consequential compensation whatsoever to the buyer nor for payment of any interest. Balmer Lawrie & Co. 20) The Bidders/ customers' workmen shall have to abide by the rules & regulation including safety & security regulation of the relevant statutory acts.
