# SCOPE OF WORK OF MASTER CHA FOR HANDLING LCL EXPORT CONTAINERS

- 1) The CHA has to collect LEO (Let Export Order) document from Shipping Line.
- 2) The CHA has to obtain Customs permission for container stuffing.
- 3) Any change or amendment during stuffing should be immediately bring to the notice of Customs.
- 4) Affixing of bottle seals in container after stuffing.
- 5) Handing over container pass out and loading order to Balmer Lawrie.
- 6) Generation of SRO and EGP for container movement to port.
- 7) Making container ready inside port after fulfilling all Customs and KoPT procedures.
- 8) Returning all document to shipping line and taking acknowledgment from them.
- 9) Handing over the acknowledgement copy to Balmer Lawrie.
- 10) Sending Container wise report on Daily basis.
- 11) Any other activity during the process of Export has to be carried out by master cha.

# **GENERAL TERMS AND CONDITIONS**

## 1. Eligibility Criteria For Techno-commercial Bid

- a) Payment of Interest Free EMD of Rs. [3,000/-]. However, MSME/NSIC bidders UNDER Micro and small category are exempted from submission of EMD.
- b) Should have valid CHA License under Kolkata Customs(Port).
- c) The bidder must have GST registration.
- d) The bidder should not have been black listed in any of the PSU's or private organizations. The company may verify such certification and if found during such verification that the statement is not true, the bid of the party will be rejected without any further reference to them.

# 2. RATE:

The rates should be quoted as per Price Bid format only which shall be including all Taxes & Duties, service charges etc. However, GST (if applicable) shall be paid by BL extra at the prevailing rate. The L-1 bidder to be determined upon total value of Contract in totality and Work Order would be placed on a single vendor.

#### 2. PAYMENT:

Payment will be made within 30 days from the date of submission of bills provided the same are correct in all respect and duly certified by Officer-in-charge of the company. Appropriate tax [if applicable] and statutory charges, if any will be deducted from the bills as per statutory regulations.
