#### **GENERAL TERMS AND CONDITIONS**

#### 1. Eligibility Criteria For Techno-Commercial Bid

- a. The bidder should be in the business of providing consultancy for BRC certification. They should submit at least 3 different work orders given by the main companies for BRC certification in the last 5 years.
- b. The tenderer shall submit an EMD of Rs.5,000/- by Pay Order/Demand draft drawn in favour of Balmer Lawrie & Co. Ltd. on any schedule bank, payable at Navi Mumbai/Mumbai. MSMED/ NSIC holders are exempted from submitting EMD.
- c. The tenderer should have valid GST registration, proof of the same is to be submitted.
- d. The tenderer should not be black listed by any PSU / Govt. department. Self-declaration for the same is to be submitted.

#### 2. VALIDITY OF OFFER

Offer must be valid for 60(sixty) days from the due date of submission of tender.

#### 3. QUOTING OF RATES

Rates shall be quoted for all the items as per format given in the attached Price Bid. The bid will be rejected if the rates are not quoted for all the items of price bid and will not be considered for evaluation.

#### 4. COMPLETION PERIOD

The entire job as per the "Scope of Work" noted hereinbefore shall be completed within three month from the date of issuance of Letter of Intent or Purchase Order whichever is earlier.

#### **5. PAYMENT TERMS**

- 1. 25% after submission of pre-audit report on prorate basis for each location.
- 2. 25% after completion of successful audit on prorate basis for each location.
- 3. 50% after obtaining the BRC certificates on prorate basis for each location.

#### 6. Submission Of Bids

The bids should be submitted in single bid process i.e. Technical / Commercial Bid, ([Unpriced] bid with Price bid)For Price Bid, only the rates are to be submitted as per given format in the online system as stated above elsewhere in the tender document.

#### 7. Tender Opening

Unpriced and price bid will be opened as per tender calendar as it is a single bid.

#### 8. Acceptance of offers

- a. Balmer Lawrie reserves the right to accept any tender in whole or in part or reject any tender or all tenders or place order for any quantity, less than or more than the tendered quantity, without assigning any reason thereof.
