(1) REQUIREMENT:

Company invites competitive offer for the following work in the SBU Leather Chemicals division, Chennai Replacement of damaged portion in 80 mm Dia Glass Lined Anchor Agitator shaft (1-Nos) top portion where Mechanical Seal is seating in 3KL MSGL Reactor.

Scope of Work:

- a) Replacement of top portion (MS shaft) of the glass lined Anchor Agitator above the vessel pad throat, which comprises of the mechanical seal seating portion and coupling area as per the dimensions given in the drawing.
- b) As per the drawing
 - The mechanical seal glass lined portion (60mm) to be sleeved with hostelloy.
 - The mechanical seal top MS portion to be sleeved with PTFE.
 - The throat portion and shaft joined area to be properly coated with PTFE.
- c) Finished shaft overall Dimensions should be maintained as per the dimensions given in the diagram for proper fixing of mechanical seal.

Remarks:

- No damage should happen in the Glass lined portion of entire agitator during execution of work
- Spark test has to be conducted wherever applicable
- The top shaft and the agitator should be in line without any misalignment.
- Service and test certificate should be submitted after the work completion.

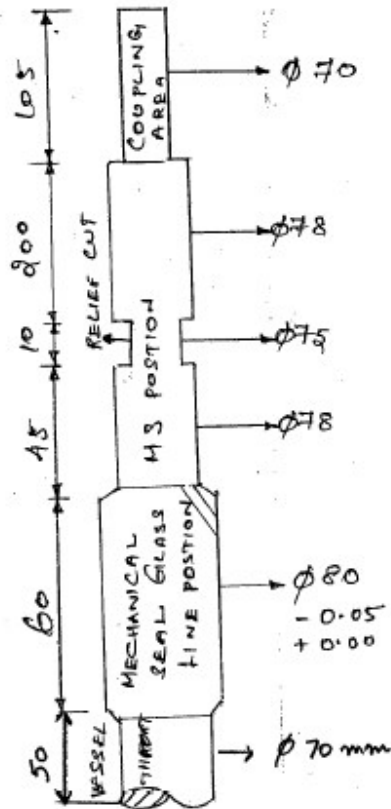
The price for the above mentioned work need to be filled in the price bid given in the Annexure-1. The price should inclusive of all charges combined together.
