1.0 General Terms & Conditions

- 1.1 **General instruction:** - Do not leave any space blank or incomplete, write NA/NIL/Free wherever applicable. Each page of the tender is to be signed and stamped as a token of acceptance of the tender terms in toto.
- 1.2 **Submission of offer:** - Bidder shall submit their offer online. However one set of tender document is to be submitted as stated above before due date of tender. No prices are to be mentioned. **Procedure for Bid Submission mentioned in details in sl no 1.18.**
- 1.3 **Acceptance of offer & placement of order:** BL reserves the right to reject/accept all or any offer(s). A tenderer must have to quote for all the items/heads provided in price bid format. In case of offer, where price for all the items/head are not quoted, such offer may be rejected. Purchase/work order will be placed on **technically & commercially qualified vendor**, whose total price **stands lowest**.
- 1.4 **Jurisdiction:** - All disputes are subject to Silvassa jurisdiction.
- 1.5 **Completion period:** The period of subject supply, to BL should be within **15 days** from the issue date of Purchase Order (PO) or LOI whichever is earlier. However, the short/early completion quoted by bidder may be preferred. The supply shall be at our works at **Survey No. 201/1, Sayli, Silvassa - 396 230.**
- 1.6 **Liquidated damages:** In case of failure to complete the job within the scheduled period by the successful vendor, a pre-determined liquidated damages will be recovered from the pending invoices @ 0.5% per week subject to a maximum of 5.0% of the basic order value.
- 1.7 **EMD/SD:** - Not required.
- 1.8 **Price schedule:** The price shall be quoted as per specified format given in Annexure-B. The price should be quoted for all the items.
- 1.9 **Payment terms:** - 100 % of PO value will be released within 30 days from the date of receipt of material and submission of certified Bill (by BL) along with all required documents, supply-challan etc.
- 1.9.1 **Performance Bank Guarantee (PBG):** - Not Applicable.
- 1.10 **Guarantee Period:** - 12 (Twelve) months from the date of successful supply of item as per PO. During this guarantee period the performance of the supplied item has to be in line with the expected/agreed quality as per tender/PO and if not then vendor has to replace/rectify the total supply at NO EXTRA COST TO BL and to the satisfaction of BL/tender.

1.20 Provisions for Micro , Small and Medium Enterprises (MSME) :

- a) Qualification Criterion: MSME vendor must confirm that UAM No has been uploaded on CPPP website as required by Ministry's circular no F:No21(17) / 2016 dated 06.04.18 for qualifying to be considered as MSME vendor under this tender. The MSME registration to specify manufacturing / service of the tender item(s).
- b) Registered MSME vendors shall be exempted from need to furnish EMD, subject to their submission of registration details. Declaration of Udyog Aadhar Memorandum [UAM Number] number by the MSME vendors on Central Public Procurement Portal [CPPP] is mandatory to qualify for availing the benefits as per Public Procurement Policy for MSMEs.
- c) Preference for Price Quotation in tenders : Participating Micro and Small Enterprises quoting price within price band of L1+15%, will qualify to supply a portion of requirement by bringing down price to L1 price in a situation where L1 price is from someone other than a Micro and Small Enterprises. Such Micro and Small Enterprises shall be allowed to supply 25 per cent of total tendered quantity for the grade at the respective plants subject to operational viability as considered appropriate by tendering authority. It may be further noted that if more than one such duly qualified MSME bidder matches non-MSME L1 price, 25% of the tender quantity will be equally split between the L1 matching MSMEs. If more than one MSME bidder has quoted in afore-said price band, number of such bidders will be intimated by tenderer to MSME bidders when seeking their acceptance to match L1 bid."
