# 1.0 Scope of Work:

### 2.0 Pre-qualification

- (i) Order/completion certificate for similar nature of jobs i.e. shifting or transportation of equipment/Mechanical maintenance work.
- (ii) PAN Card
- (iii) Goods & Services Tax Registration Certificate

# 3.0 Scope of Work & Responsibility of the Bidders

3.1 Bidders may visit the Refinery to assess the entire scope of work with prior intimation to our site in- charge at the following address:

- 3.2 The driver of each vehicle (Truck & Trailler) should be accompanied with helper.
- 3.3 Arranging entry and exit passes for men and vehicles are the responsibility of the bidder.
- 3.4 Loading & unloading of material shall be carried out in a safe manner and all the materials will have to be properly secured with the vehicles to the satisfaction of Balmer Lawrie's personnel so as to eliminate possibilities of any damage and overturning during transit.
- 3.5 Placement and positioning of plant & machinery in the plant/dyke shall be made through suitable capacity of hydra/crane as required.
- 3.6 Necessary co-ordination with all concerned viz. Balmer Lawrie, IOCL and CISF for carrying out the material loading & unloading shall be the responsibility of the bidder so that, the loading/unloading is carried out smoothly and without undue delay.
- 3.7 Bidders should quote lump sum rate for each internal shifting based on above scope. The rate will be fixed irrespective of duration of shifting.
- 3.8 The order will be placed on strict understanding that the bidder has indemnified Balmer Lawrie & Co. Ltd. against any government action on them or their vehicles or drivers while on our duty.
- 3.9 Our decision will be final in the event of any dispute.
- 3.10 The vendor must keep Balmer Lawrie & Co. Ltd. fully absolved from all legal responsibilities arising out of any accident, injury, death etc. to his staff / labourers involved in the operation.
- 3.11 Rates should be valid for acceptance for a period of 90 days from the due date.

- 3.12 Rates quoted should be firm and no escalation, whatsoever, will be granted within the contract period.
- 3.13 Bidders should strictly adhere safety norms of the Refinery and drivers of the vehicles should have the following documents:
  - a) Registration Certificate (RC) book of the Vehicle.
  - b) Valid Fitness Certificate of the Vehicle
  - c) Valid Insurance Policy of the Vehicle
  - d) Driving License of the Driver
  - e) Valid Pollution Control Certificate of the Vehicle
  - f) Any Photo Identify of the Helper/Khalasi accompanying the drive
  - g) Vehicles should have Fire Arrester, Fire Cylinder and stepney

In absence of any of the above documents, the vehicles will not be allowed inside the Refinery.

#### 4.0 <u>Completion Schedule</u>

Loading, Unloading and Internal shifting should be completed within 7 (seven) days from the date of intimation.

#### 5.0 Penalty

Penalty @ 1% of the basic value of each shifting per day or part thereof subject to a maximum of 5% shall be levied for delay in completion of work. Any damage to our plant & machinery shall be recovered from the bill unless such damage is compensated by our insurer.

#### 6.0 <u>Transit Insurance</u>

The plant & machinery owned by Balmer Lawrie are covered with requisite insurance.

#### 7.0 <u>Goods & Service Tax (GST)</u>

Payment of GST shall be extra and paid as per statute. The current rate is 18%. Balmer Lawrie's Bihar GST No. is : 10AABCB0984E1ZA..

#### 8.0 Incidental Charges

All incidental charges, if any, shall be under bidder's scope.
