2. The driver should carry necessary documents including RC Book, tax receipt, insurance policy of the vehicle, original driving licence, identity cards etc.
3. In case of failure of the contractor to place required vehicles on time/arrange transportation. BL reserves the right to utilize the services of any other transporter without notice at the risk and cost of the contractor and to recover charges and expenses in excess of the contractual obligations , the work shall be completed at the risk of the contractor and cost through alternative source /arrangements. This will be without prejudice to the right of BL for any other action including termination

4. Payment after deduction of TDS as per rules would be made within 15 days on submission of bills.
5. The transporter should specify service tax is applicable with their registration number and the rate.
6. Rate offered should be firm during the currency of the contract.
7. Any incidental expenses incurred at warehouses shall be borne by the contractor
8. Only the lowest quoted (L1) transporter will be awarded the contract.
9. Company reserves the right to reject/accept any/all offers without assigning any reason.
10. Company also reserves the right to split the order for more than one contractor.
11. The successful tenderer shall not be allowed to sub-let either wholly or any part of the order without the Company's prior written consent.
