Terms & Conditions:

- 1) 100% payment will be made within 30 days of submission of the bills along with the Delivery Challans and satisfactory completion of the job.
- 2) Transporter should ensure cargo should be delivered in sound condition with all safety precautions.
- 3) Transporter will be responsible for payments on account of fuel, running, repairs & maintenance, upkeep, insurance, safety, taxes or levy or any penalty for any reason in relation to the vehicle. Drivers of the transporter should hold valid driving licenses. Contractor will be solely responsible to comply with all local & central laws relating to running/ownership of such commercial vehicles and shall arrange inter-state permits in advance at his costs only. All relevant papers of the vehicle such as RTO Clearance, Fitness, Insurance, License, inter-state permits etc., must be available with the vehicle
- 4) If transporter fails to place the trailer and to effect the movement within reasonable time, the company shall be free to engage any other transporter. The charges being incurred in engaging any other transporter will be recovered at actual from the transporter.
- 5) In case of any loss incurred due to non-delivery/late delivery/ misplacement/damage of the consignment while under the possession of the transporter, the damages claimed by the client are recoverable from the Transporter
- 6) In case of detention of vehicles due to any lapse on the part of the transporter or its drivers or the owner of the vehicles, no claim for detention charges shall be entertained by the company.

- 7) The company will not be liable to pay detention charges / any other charges in consequence of Bandh / declared strike, Lock out /lock down, natural calamities, revolution, Riots, pandemic, wars, acts of enemies of the state
- 8) The transporter should have handled similar jobs in the past for Govt. Dept. / PSUs / reputed corporate customers.
- 9) While transporting the goods, the transporter will strictly adhere to the following principles of safety:
 - a. The driver and cleaner to each vehicle must be available with the convoy during loading, transit & unloading of the consignments.
 - b. Transporter must ensure that the cargo is covered and protected from rain with the use of Tarpaulin etc.,
 - c. The transporter must ensure the compliance of law applicable in state where the good are being transported from / to along with transit states.
- 10) Bids of any tenderer may be rejected if a conflict of interest between the bidder and the company is detected any stage.
- 11) The vendor should compulsorily follow all the provisions of the GST Law. Noncompliance of GST Law by transporter will be his sole responsibility and any liability arising due to that has to be borne by transporter.
