Work covered in this tender document shall generally be as detailed herein below. However, contractor shall be responsible to complete the work in all respects and in doing so provide/supply all facilities which may not be explicitly covered below but nevertheless are required to complete the work envisaged with the exception of only such items as have been specifically excluded from contractor's scope.

The successful tenderer shall have to undertake the following work:-

- a. Supply-Installation of Heavy Duty Decking Panels to our existing Selective Pallet Racking System for G+5 levels as per **Technical Specifications**
- b. To provide Test Certificate from a Third Party as per the recommendation by BL satisfying the load criteria mentioned elsewhere in the tender.

Site Visit: Vendors are advised to visit the site and ask clarifications if required prior to their participation in the tender bid.

DESIGN GUIDELINES

The following standards are to be used for design of Racking system.

- IS 801:1975 Code of practice for use of cold formed light gauge steel structural members in general building conditions.
- IS 800:1984/2007 Code of practice for general construction of steel.
- BS: 5950 (V): 1988 Building design using cold formed steel sections.
- FEM 10.2.02 Code of practice for design of steel pallet racking.
- FEM 10.3.01 Adjustable beam pallet racking, tolerances, deformations and clearances.
- EN:15512:2009 Steel static storage system Adjustable pallet racking systems Principle for structural design.
- SEMA Code of practice for the design of static racking.

RAW MATERIAL

Load Bearing Members of the system are to be made out of high strength HR steel having properties equivalent to grades specified by IS 5986: 2002 and IS 2062: 2006.

In addition to high strength, the raw material used for **structural load bearing members should possesses adequate ductility to ensure toughness.**

Raw material traceability should be available at vendor plant to trace mother coil of all components.

• PALLET SUPPORT BAR

- 1. Utility: Pallet support bars are to be provided to make the racking system more flexible by allowing non uniform depth pallet sizes to be stored, as well as for pallets to be stored in cross way. It is provided for every beam level in 115 units (B TYPE). 3 PSBs per pallet position is to be provided, i.e. 6 PSBs per loading level.
- 2. Profile should be **Lipped C with 6 bends**.
- 3. Resting surface of the PSB is to be 65mm.
- 4. Manufacturing is to be **press formed and welded**.
- 5. Surface finish is to be **epoxy polyester powder coated.**

4 BEND DECKING PANEL

- 1. Utility: Decking surface on loading levels to be provided for every beam level in 59 units (A TYPE).
- 2. Profile: Should be C section of the required thickness as per the design..
- 3. Manufacturing should be press formed.
- 4. Deflection criteria shall be less than span / 200 and tested as per FEM 10.2.06.
- 5. The panels should be arranged in a series of beams. Panel support bars to be used for fixing.
- 6. Finish should be epoxy polyester powder coated of recommended colour by BL

• COLUMN GUARD

Upright guards are grouted in front of all aisle facing uprights. This is to avoid any accidental direct hit on bottom of racks by Fork Lifts or Stackers while handling pallets/cargo.

- 1. Type of Profile: Stiffened "C" profile.
- 2. Height: 400mm.
- 3. Connectivity: Grouting.
- 4. **Fasteners**: 3 No of M12 x 100
 - 4 No of M10 x 25 Hex.Bolt

LOAD

Sizes of the Deck Sheet should be designed in such a way it should take a load of 1.5x2 MT on deck panels provided on unit of size 2710mmx1000mm.

• PRETREATMENT AND SURFACE FINISH

Pre-treatment:

All components of the system are to be supplied duly finished with **Epoxy-Polyester powder coating** after doing the surface treatment of all the items by using pre-treatment method as mentioned below.

1. <u>Pre-treatment</u>: All components are to be subjected to a **Five Zone 7-tank special pre-treatment**.

The pre-treatment process should consists of degreasing, phosphating and final rinse with

demineralized water. All of the above mentioned processes are to be interspersed with rinsing

with water of appropriate temperature.

- 2. <u>Degreasing</u>: Degreasing is to be carried out with the help of a **two step chemical process within** controlled temperatures.
- 3. The degreasing should conform to the requirements of IS: 3194 / 6005 1980.
- 4. Phosphating: Phosphating to be carried as per IS: 6005 and IS: 3618 Class D.
- 5. After phosphating, cold water rinse is to be done using two different tanks and one final rinse is done with RO water to remove all traces of retained chemicals.
- 6. <u>Dry off oven treatment</u>: The material should be dried up using drying oven at an air temperature of 125 deg C.

Final Finish :

- 1. Uprights, beams and other items to have **Epoxy Polyester powder coating (lead free)** of the colour and shade is applied to all components with an **average dry film avg. 35 microns.** Bracings are galvanized.
- 2. The material components are to be **oven baked within a controlled temperature as specified by Powder Manufacturer for a flawless finish.**
- 3. The finish is to be as strong so as to withstand a 2H pencil hardness test.
- 4. Testing of paint for various physical and chemical properties to be done as per IS 101:1964



GENERAL TERMS AND CONDITIONS

01. Eligibility Criteria For Techno-Commercial Bid

- a) Interest Free EMD of Rs. Rs 10,000/-. (Ten thousand)To be submitted online Declaration of Udyog Aadhar Memorandum [UAM] number by the MSE vendors on Central Public Procurement Portal [CPPP] is mandatory to qualify for availing the benefits as per Public Procurement Policy for MSEs.

The completion certificate should include following Details:-

- 3. Date of completion/ Duration.
- 4. Name of agency executed.

The completion date of the work orders with executing similar works shall be deciding factor to conclude whether the job has been executed in the qualifying period or not. The value of final executed work shall only be

considered while evaluating the individual work order value.

5.TDS certificate generated from TRACES and Bank account statement(s) showing the payment received in respect of work orders submitted against Pre-Qualification criteria is to be submitted by the bidders, if it is demanded by Balmer Lawrie. The said documents must be for the work executed between the periods indicated there only.

6.Bidders are required to ensure that the value of completed job indicated by them is exclusive of Service Tax/Goods and Services tax. Accordingly, the completion certificate submitted by the bidder shall separately indicate the service tax/Goods and Services tax amount included in the value of completed job OR a separate certificate from the respective client, mentioning the service tax/Goods and Services tax amount, if any, included in the value of completed job under consideration should be submitted by the bidder.

Power for general lighting required for the work shall be provided by the company.

10. Completion Period

Time is the essence of the contract. The Job shall be completed within (ninety days)3 months from the date of Letter of Intent (LOI)/ Purchase Order (PO) whichever is earlier.

11. Payment Terms

- a) **90% against** Supply, Installation and successful completion of job upon verification and certification by the Engineer- in-Charge.
- b) The retention money which will be 10% of the contract value will be released after completion and acceptance of work against issue of Bank Guarantee of the equal amount for defect liability and performance maintenance period, which shall be twelve (12) months from the date of completion of job. Performance Bank Guarantee shall be issued by any Nationalized /Scheduled Bank on basic value of material supplied and shall remain valid for above guarantee period.
- c) No mobilization advance will be paid and no advance payment will be done.

12.Security Deposit/EMD

- (i) The successful bidder will submit 5% of the whole contract value as security deposit within 7 days of confirmation of work order. It can be in the form of demand draft/Bank Guarantee BG from scheduled bank in favour of Balmer Lawrie and Company Limited and payable at Kolkata.
- (ii) If bidder fails to provide the Security Deposit within the period specified, such failure will constitute a breach of the Contract and Balmer Lawrie shall be entitled to award the Work elsewhere at Contractor's risk and cost. The Security Deposit shall be released to the

contractor after completion of work, final bill payment & after submission of Performance Bank Guarantee covering the defect liability /warranty period .

- (iii) No interest shall be payable against Security Deposit.
- (iv) Wherever the Security Deposit / Retention Money is furnished by Contractor in any form other than cash or Demand Draft, Contractor shall be entirely responsible to keep such form of security deposit enforceable by BL by extending the validity thereof if required, by removing the restrictions thereon within one month before the enforceability thereof by BL is likely to expire and keep them enforceable, until released by BL after the Defect Liability Period.
- (v) The Security Deposit / Retention Money shall remain at the entire disposal of BL as a security for satisfactory execution and completion of the Work(s). BL shall be at liberty to deduct and appropriate from the Security Deposit / Retention Money such damages (liquidated or otherwise) and other dues and recoveries from Contractor under this Contract and the amount by which Security Deposit / Retention Money is reduced by such appropriations, will be made by further deductions from Contractor's subsequent bills to that extent as to make up the Security Deposit / Retention Money.
- (vi) Notwithstanding anything to contrary, in as much as the Security Deposit is to be in cash with BL, BL shall be entitled to enforce any of the approved forms of Security Deposit furnished by Contractor at any time and realise cash thereof irrespective of whether or not Contractor disputes such right. However, if Contractor obtains the extension of the time limit, if any, for the enforceability of such form of Security Deposit and intimates BL of such extension within one month before expiry, BL may not enforce such form of Security Deposit, unless it has otherwise become enforceable.
- (viii) On due and satisfactory performance of all the obligations of Contractor under this Contract including completion of work in all respects, carrying out the obligations of Contractor during the work and issue of completion certificate Security Deposit will be returned on submission of Performance Bank Guarantee(PBG) for 10% of retention money from the basic cost of contract based on executed value for the defect liability period. Retention Money shall be released by BL subject to recoveries, deductions and retentions therefrom as provided under the Contract after the defect liability period.
- (ix) Security deposit has to be paid by MSE vendors too.

For the successful bidder, the EMD will be refunded only after they submit the necessary Security Deposit against the work order placed on them.

For the unsuccessful bidders, the EMD will be refunded only after the successful bidder has accepted the Purchase order and the acknowledgment of the same has been received by Balmer Lawrie (BL).

EMD is liable to forfeiture in the event of:

- a) Withdrawal of offers during validity period of the offer
- b) Non acceptance of orders by the bidder within the stipulated time after placement of order.
- c) Any unilateral revision made by the bidder during the validity period of the offer.
- d) Non submission of Security Deposit.
- e) Bidders submitting false/fabricated/bogus documents in support of their credentials

13. Liquidated Damages (LD)

(i) If the contractor is unable to complete the jobs specified in the scope of work within the period specified in the NIT, He may request the owner for extension of time with unconditionally agreeing for payment of LD. Upon receipt of such a request, owner may at its discretion extend the period of completion and shall recover from the contractor, as an ascertained and agreed Liquidated Damages, a sum of 0.5% of contract value for each week of delay or part there of subject to a maximum of 10% of contract value.

The parties agree that the sum specified above is not a penalty but a genuine pre estimate of the loss / damage which will be suffered by the owner on account of delay / breach on the part of the contractor and the said amount will be payable without proof of actual loss or damage carried by such delay / breach.

(ii) Notwithstanding what is stated in Clause above, the Owner shall have the right to employ any other agency to complete the remaining work at the risk and cost of the Contractor, in the event of his failing to complete the work within the stipulated time.

14. Performance Guarantee & Warranty

- (i) Performance Guarantee:
 - a) The contractor shall guarantee that the workmanship of work done is as specified in the tender schedule and wherever there is nothing specifically mentioned shall correspond to the best available grade and quality as required for the application.
 - b) The contractor shall also guarantee that the work done shall be as per prevailing relevant standard, codes and statutory practices / stipulations.
 - c) The contractor shall guarantee the work done d by him against defective materials, poor workmanship,, operation inadequacies & problems and failure from normal usage, for a period of 12 (twelve) calendar months after final acceptance of the work by the BL and issue of completion certificate
- (ii) Warranty:

The Contractor will rework the defects found which shall be notified to him in writing within the Defect Liability Period provided that such defective work are promptly rectified and reworked by him free of cost.

14. TENDER CONDITIONS FOR BENEFITS / PREFERENCE FOR MICRO & SMALL ENTERPRISES (MSES)

- 14.1 As Per Public procurement Policy for Micro & Small Enterprises (MSEs) Order, 2012 issued vide Gazette Notification dated 23.03.2012 by Ministry of Micro, Small and Medium Enterprises of Govt. of India, MSEs must be registered with any of the following in order to avail the benefits/preference available vide Public Procurement Policy MSEs Order,2012
- a. District Industries Centers (DIC)
- b. Khadi and Village Industries Commission (KVIC)
- c. Khadi and Village industries Board and Coir Board

- e. National Small Industries Corporation (NSIC)

- 14.2 MSEs participating in the tender must submit the certificate of registration with any one of the above agencies.
- 14.3 The registration certificate issued from any one of the above agencies must be valid as on close date of the tender. The successful bidder should ensure that the same is valid till the end of the contract period.
- 14.4 The MSEs who have applied for registration or renewal of registration with any of the above agencies/bodies, but have not obtained the valid certificate as on close date of the tender, are not eligible for exemption/preference.
- 14.5 Registered MSME vendors shall be exempted from need to furnish EMD, subject to their submission of registration details.
- 14.6 Declaration of Udyog Aadhar Memorandum [UAM Number] number by the MSME vendors on Central Public Procurement Portal [CPPP] is mandatory to qualify for availing the benefits as per Public Procurement Policy for MSMEs
- 14.7 Price Preference Subject to meeting terms and conditions stated in the tender document including but not limiting to prequalification criteria, 25% of the total quantity of the tender is earmarked for MSEs registered with above mentioned agencies/bodies for the tendered item. Where the tendered quantity can be split, MSEs quoting a price within a price band of L1+15% shall be allowed to supply 25% of total tendered quantity provided they match L1 price. In case the tendered quantity cannot be Split, MSE shall be allowed to supply total tendered quantity provided their quoted price is within a price band of L1+15% and they match the L1 price. In case of more than one such MSEs are in the price band of L1+15% and matches the L1 price, the supply may be shared proportionately.

15. Compliance of GST

The vendor should compulsorily follow all the provisions of GST and in the event any default for fulfilling any provisions of the GST Act, Balmer Lawrie & Co. Ltd. would exercise the right for non-payment/withholding payment, / black listing the vendor.

16. ESI/PF/Other Statutory obligations

The Contractor would be required to ensure adherence to all statutory obligations related to their employees who would be working inside Balmer Lawrie premises. On award of the contract, the bidder shall ensure compliance with all relevant statutory provisions under the relevant labour laws which are as given below:

- a) The Contract Labour (Regulation & Abolition) Act 1970
- b) The Employees Provident Funds and Miscellaneous Provisions Act 1952
- c) The Employees State Insurance Act 1948
- d) The Minimum Wages Act 1948
- e) The Workmen Compensation Act 1923

and other applicable labour enactment and as amended from time to time in respect of the personnel deployed by bidder at the Company's premises.

The personnel deployed in the Company's premises by the Contractor shall be fully qualified in all respects to carry out the activities for which he/she has been deployed.

It may be noted that the bill submitted by successful bidder for services rendered shall be processed only on submission of satisfactory proof of remittances Challans in respect of statutory payments such as ESI, PF, etc. for the personnel deployed by him in the Company's premises along with the ESI/PF numbers allotted to them. Cost if any, incurred by the Company in ensuring statutory compliance with the existing labour enactment and as amended from time to time shall be fully charged to the contractor.

17. Third Party Liability Insurance: The third party liability shall cover the loss / disablement of human life (persons not belonging to the Contractor) and also cover the risk of damages to others' materials / equipment / properties during construction, erection and commissioning at site. The value of third party liability for compensation for loss of human life or partial / full disablement shall be of required statutory value but not less than Rs. 2 lakh per death, Rs. 1.5 lakh per full disablement and Rs. 1 lakh per partial disablement and shall nevertheless cover such compensation as may be awarded by a Court of Law in India or abroad and cover for damage to others' equipment / property. Site handover would not be done unless Insurance documents are handed over to Executing Authority,

18. Sub-letting of Work

No part of the contract or any share or interest therein shall in any manner or degree be transferred assigned or sublet by the contractor directly or indirectly to any person, firm or corporation without the consent in writing from Balmer Lawrie. In the event of contractor contravening the conditions, Balmer Lawrie shall be entitled to get the work done from any other firm at the 'Risk & Cost' of the contractor.

19. Indemnity

The Contractor will be required to indemnify and keep indemnified the Company against all losses and claims for injury and damage to any person or any property whatsoever which may arise out of or in consequence of the work and against all claims, demands, proceedings, damages, cost charges and expenses whatsoever that may arise against the company on account of the faults of the contractor/his workmen/due to malfunctioning of the equipment's employed by the contractor. The company may forward the bidder any such claim demand or

complaint made by any other person against the company. In such event, the contractor shall solely be liable for the disposal of the said complaint. The contractor will be required to Indemnify and absolve the Company of all responsibilities related to employment condition of their employees and should adequately safeguard Company against any possible IR problems including those related to employment. Further, Company will not have any liability towards employment, remuneration or compensation in whatever manner made to the employee of the bidder. Such demand shall be settled by the bidder directly. The Contractor shall co-operate with the company in all matters relating to introduction/adoption of new equipment technology, machinery, compliance of all relevant laws, rules or regulations, relating to CFS operations and implementation of any scheme/policies/guidelines recommended by the Company aimed at swift and better customer service.

20. Termination

20.1 Termination on expiry of the CONTRACT

This Agreement shall be deemed to have been automatically terminated on the expiry of the CONTRACT period unless the BL has exercised its option to extend this CONTRACT in accordance with the provisions, if any, of this CONTRACT.

20.2 Termination on account of force majeure

Either party shall have the right to terminate this CONTRACT on account of Force Majeure, as set forth in clause

20.3 Termination on account of insolvency

In the event the CONTRACTOR or its collaborator at any time during the term of this Agreement becomes insolvent or makes a voluntary assignment of its assets for the benefit of creditors or is adjudged bankrupt, then the BL shall, by a notice in Writing have the right to terminate this CONTRACT and all the CONTRACTOR's rights and privileges hereunder, shall stand terminated forthwith.

20.4 Termination for unsatisfactory performance

If the BL considers that the performance of the CONTRACTOR is unsatisfactory or, not up to the expected standard, the BL shall notify the CONTRACTOR in writing and specify in detail the cause of such dissatisfaction. The BL shall have the option to terminate this Agreement by giving 30 days' notice in writing to the CONTRACTOR, if, CONTRACTOR fails to comply with the requisitions contained in the said written notice issued by the BL.

20.5 Consequences of termination

In all cases of termination herein set forth, the obligation of the BL to pay shall be limited to the period up to the date of termination. Notwithstanding the termination of this Agreement, the parties shall continue to be bound by the provisions of this Agreement that reasonably require some action or forbearance after such termination.

21. Force Majeure Conditions:

Any delay in or failure of the performance of either part hereto shall not constitute default hereunder or give rise to any claims for damage, if any, to the extent such delays failure of performance is caused by occurrences such as Acts of God or an enemy, expropriation or confiscation of facilities by Government authorities, acts of war, rebellion, sabotage or fires, floods, explosions, riots, or strikes. The Vendor shall keep records of the circumstances referred to above and bring these to the notice of the Engineer-In-Charge in writing immediately on such occurrences. The amount of time, if any, lost on any of these counts shall not be counted for the delivery period. On decision of BL/BL arrived at after consultation with the Vendor, shall be final and binding. Such a determined period of time be extended by the BL to enable the Vendor to deliver the items within such extended period of time.

If Vendor is prevented or delayed from the performing any of its obligations under this agreement by Force Majeure, then Vendor shall notify BL the circumstances constituting the Force Majeure and the obligations performance of which is thereby delayed or prevented, within seven days of the occurrence of the event.

24. Arbitration

Any dispute or difference arising under this Contract shall be referred under jurisdiction of Kolkata to a sole arbitrator to be appointed by the Chairman & Managing Director, Balmer Lawrie & Co. Ltd. and the provisions of Arbitration Act, 1996 including any statutory modifications or enactment thereof shall apply to the Arbitration proceedings. The fees of the arbitrator, if any, shall be shared equally by both the parties. The award shall be a speaking award stating reason therefor and is final & binding on the parties. The proceeding shall be conducted in English language and courts at Kolkata will have exclusive jurisdiction to settle any dispute arising out of this contract.

25. **EXTRA ITEMS OF WORK**

During the course of execution of the work, should the contractor come across items of work which are not covered under the Schedule of Rate or not included therein, the Contractor shall draw the attention of the Engineer-in-Charge to the same and such items of work shall be treated as extra only with the prior approval of Engineer-in-Charge in writing. Contractor shall submit a quotation along with the rate analysis for such accepted extra items before he commences work or purchases the materials in connection with such items.

For extra items, rates shall be derived from similar item rates included in the schedule of work. Where there is no such similar item available in the schedule, rate shall be analysed as follows:

Rate for extra item = Cost of material (a) + cost of labour inclusive of all necessary tools, tackles, equipment, machinery and consumable (b) required to carry out the work + 15% of (a+b) towards profit and overhead + taxes, duties etc.

26. **INSPECTION & TESTING**

All work will be subject to inspection by BL/authorized representatives of BL as per the relevant codes, standards and specification. All arrangement & costs, if any, for conduction tests during inspection at vendor's works will be deemed to be included in the quoted prices.

It shall be the option of BL/ authorized representative to allow the Vendor to redo the work or to cancel the Order for the goods rejected. All costs for carrying out inspection including that required for making arrangements for the same shall be borne by the contractor.

27. <u>COMPLETION CERTIFICATE</u>

(i) When Contractor fulfils his obligation under clauses he shall be eligible to apply for Completion Certificate. Contractor may apply for separate Completion Certificate in respect of each such portion of Work by submitting the completion Documents along with such application for Completion Certificate.

The Engineer-in-Charge shall normally issue to Contractor the Completion Certificate within one(1) month after receiving an application therefore from Contractor after verifying from the completion documents and satisfying himself that work has been completed in accordance with and as set out in the technical specifications and BOQ, and the Contract Document and rectification of defects if any.

Contractor, after obtaining the Completion Certificate, is eligible to present the Final Bill for Work executed by him under the terms of Contract.

(ii) Within one (1) month of completion of work in all respects, Contractor shall be furnished with a certificate by the Engineer-in-Charge, of such completion, but no certificate shall be given nor shall work be deemed to have been executed until all scaffolding, surplus materials and rubbish is cleared off Site completely nor until work shall have been measured by the Engineer-in-Charge whose measurement shall be binding and conclusive. Work will not be considered as complete and taken over by BL, until all the temporary works, constructed, are removed and the worksite cleaned to the satisfaction of the Engineer-in-Charge.

If Contractor shall fail to comply with the requirements of this clause on or before the date fixed for the completion of Work, Engineer-in-Charge may at the expenses of Contractor remove such scaffolding, surplus materials and rubbish and dispose of the same as he thinks fit and clean off such dirt as aforesaid, and Contractor shall forthwith pay the amount of all expenses so incurred and shall have no claim in respect of any such scaffolding or surplus materials as aforesaid except for any sum actually realised by the sale thereof.

- (iii) For the purpose of clause, the following Documents will be deemed to form the completion Documents:
 - (a) Joint Inspection Report
 - (b) Completion proof for any job that has to be re-done or re-worked due to poor workmanship/substandard quality of work
 - (c) Removal of all equipments and debris or any other material from the site of work

Contractor should also submit the necessary documents before bringing in or taking out their own materials/equipment from the site. No material/equipment can be taken out from site without prior approval of Engineer-in-Charge.

28. FINAL CERTIFICATE

Upon expire of the period of defect liability and subject to the Engineer-in-Charge being satisfied that work have been duly maintained by Contractor, during such period as herein before mentioned and that Contract has in all respect duly made up any subsidence and performed all his obligations under Contract, the Engineer-in-Charge shall (without prejudice to the rights of Balmer Lawrie to retain the provisions of relevant clause hereof) otherwise give a certificate herein referred to as the final certificate to that effect and Contractor shall not be considered to have fulfilled the whole of his obligations until Final Certificate shall have been given by the Engineer-in-Charge notwithstanding any previous entry upon Work and taking possession, working or using of the same or any part thereof by Balner Lawrie Contractor shall provide Balmer Lawrie with a certified satisfactory to both that all privileges, liens, claims, obligations and liabilities against or chargeable to the Owner have been fully paid, satisfied and released and that Contractor has no claim(s) against Balmer Lawrie.

29. HSE Clause

- **A.** a) The contractor and his workers must strictly take all safety precautions and shall supply to his workers dependable safety appliances like hand gloves, safety boots, safety belt, safety helmets, duster cloth, dust mask/nostril filter etc. In addition to this, contractor shall also provide additional safety appliances as per requirement and follow safe working practices like using fully insulated electrode holders etc. He shall also ensure that his workmen intelligently use only dependable safety appliances supplied to them.
 - b) The contractor shall take adequate safety precaution to prevent accidents at site. The contractor shall also ensure that his employees observe the statutory safety rules and regulations and also those laid down by the employer from time to time and promptly submit report of accident and state the measures taken by him to prevent their recurrence and also keep the employer indemnified of all claims arising out of such accidents.
 - c) No Workmen shall be engaged on the work without proper safety induction and without using required PPE. Use of safety helmet and shoe is must excepting in painting works where shoe will not be used.
 - d) All workmen employed within Balmer Lawrie site should be in sound and intoxicated health condition. Balmer Lawrie may ask for a health certificate of any workmen employed by Contractor at site anytime before/during/after execution of job at site.
