## TERMS AND CONDITION

1. The term “**Company (or) BL**” wherever mentioned in the tender document refers to “**BALMER LAWRIE & CO. LTD.**”
2. The term “**bidder**” means the firm or company with whom the order is placed and shall be deemed to include the bidder, successors, representatives, heirs, executors and administrators duly approved by the company.
3. Period of Supply: **Within 30 days from the date of receipt of our Purchase order including commissioning the Seamer OH/TH Quick Change Over Attachment.**
4. In order to get acquainted with the existing set-up, the bidders are requested to visit our plant during all working days between **10.00AM to 4.00PM** well before the due date of the tender to study the existing infrastructure which will be helpful to give their complete offer accordingly.
5. The offer shall be submitted in our enquiry format only and any Conditional offers will be discretion of BLCL.
6. The offer must be kept valid for a minimum period of **60 Days from** the date of opening the offer.
7. The price quoted by the bidder shall remain valid till the supply is completed. During the tenure of the supply period, no price increase will be considered, except for change in statutory levies imposed by Union / State Govt. / Local authorities.
8. It may be noted that the order shall be finalized only on the lowest quoted bidder and it would be in the interest of the **bidder to quote the most competitive price.**
9. Payment: **90% of the payment within 30 days from the date of Commissioning the Seamer OH Quick Change Over Attachment and balance 10% will be kept as a retention Money for performance and the same will be released after 90 days from the date of Commissioning the Seamer OH Quick Change Over Attachment.**
10. **Penalty Clause:** Any failure on the part of the vendor to supply the material as per the delivery schedule, required quantity, approved quality etc. will be viewed seriously. The vendor may be debarred from participating in future tenders of the company.
11. The bids of any bidder may be rejected if a conflict of interest between the bidder and the Company is detected at any stage.
12. Late tenders / delayed tenders including postal delay and those not conforming to the prescribed terms and conditions will not be considered at all.
13. The company would not carry out any negotiations except with such bidders who is / are the lowest quoted bidders originally. As such it would be in the interest of the bidders to quote the lowest possible rate.
14. It shall be understood that every endeavor has been made to avoid error which may materially affect the basis of the tender and the successful bidder will take upon himself to provide for risk of any error which may subsequently be discovered and shall make no subsequent claim on account thereof.
15. Only Registered vendors are eligible to apply. Bids from non-registered vendors are liable to be rejected. Any non-registered vendor interested in supplying the material/service may register with the company and shall be eligible for participation from the next tender onwards.

16. **ARBITRATION:-** Any dispute or difference arising under this Contract shall be referred under jurisdiction of Chennai to a sole arbitrator to be appointed by the Chairman & Managing Director, Balmer Lawrie & Co. Limited and the provisions of Arbitration and Conciliation Act, 1996 including any statutory modifications or enactment thereof shall apply to the Arbitration proceedings. The fees of the arbitrator, if any, shall be shared equally by both the parties. The award shall be a speaking award stating reason therefor and is final and binding on the parties. The proceeding shall be conducted in English language and courts at Chennai will have exclusive jurisdiction to settle any dispute arising out of this contract.

### **SCOPE OF JOB**

1. In the seamer machine from Tight Head barrel to Open Head barrel and vice versa change over system has to be modified to make the change over work quickly. For the same, the modifications in the seaming operation of top side of the seamer machine has to be modified fully in first operation and second operation. The top side of seaming process which is carried out by the cam shaft, cam and sliding operating mechanism should be modified such a way the total change over time of seaming machine should be completed in 5 minutes without any fasteners fixing or dismantling.
2. The successful bidder should design the quick change over system with the replacement of the existing system. However, there should not be any huge modifications in the machine. In the design there should be provision for electrical interlocking to avoid any accidents during running of the machine.
3. The successful bidder should make correct drawings and the drawing should be handed over to BL during the time of successful commissioning.
4. The successful bidder has to fabricate all the cam, cam shaft and other operating attachments and supply to BL.
5. The successful bidder should commission the attachment in the machine by his own in the machine. However, other assistance like, providing power, if required manpower assistance and available normal type of tools.
  - A. The commissioning job should be completed within 2 days time frame in order to release the machine from production schedule.
  - B. The commissioning job will be planned on Sundays/ Holidays only to avoid production loss.
