## 3) Filling of Tender Documents

- 3.1 The tenderers are requested to carefully study all the tender documents and tender conditions before quoting their rates.
- 3.2 The tender must be strictly in accordance with the terms and conditions as laid out in the tender.

**Any counter terms and conditions given by the tenderer in their offers will not be binding on Balmer Lawrie.**

The sole proprietor or authorized representative shall sign all documents that need to be uploaded. When the person signing the documents is not the sole proprietor / authorized representative of the company, the Power of Attorney authorizing such person to act and sign on behalf of the company must be scanned and uploaded and produced later on for verification by Balmer Lawrie.

### **SCOPE OF WORK**

Work covered in this tender document shall generally be as detailed here in below. However, contractor shall be responsible to complete the work in all respects and in doing so provide/supply all facilities which may not be explicitly covered here in below but nevertheless are required to complete the work envisaged with the exception of only such items as have been specifically excluded from contractor's scope.

The successful tenderer shall have to undertake the following work:

#### **Detailed Scope of work:**

We propose Transporters are arranged to 1 x 40 feet Flat Rake and 2 x 40 feet open top Containers (in gauge) by 40 feet trailers from Mumbai, Nhavasheva to IMT, Rohtak, Haryana (Round trip basis).

#### ***1. The broad responsibility areas of the Contractor will inter alia be as under:***

Besides;

- a. The Transporter must place valid RTO approved vehicles, all the Rules & regulations of need to be followed for carrying the cargo.
- b. The Transporter should not violate the Law of Land and carrying capacity of each vehicle as per Governing Laws of the land.
- c. It is sole responsibility of the transporter to ensure proper route survey done prior to movement of the cargo .
- d. Transporter also ensure feasibility study of route preferred or alternative one.
- e. To undertake to collect pick up / delivery documents from our operation staff at the loading / pick up points or wher ever necessary.
- f. The contractor needs to submit Endorsed on LR (with gate in and gate out date Signed and stamped at Factory) or any other document being the Supporting for detention if anyetc.,

The above list is only illustrative and not exhaustive and the contractor will arrange for necessary transportations works as and when required and as instructed by the company officials.

#### **2. Deployment of vehicles**

The Contractor will be required to place the vehicles immediately on award of contract as per the instructions from time to time.

The contractor should take out a third party insurance cover for all vehicles to adequately cover for damage, loss or injury to any person/material during the execution of the services.

It will be the contractor's responsibility to ensure proper maintenance of the vehicles. All expenses on this account will be borne by the contractor. Cost of statutory charges including RTO License, Insurance charges and all the related running costs such as driver's wages (who should have valid driving license), fuel, lubricants, maintenance, etc shall be borne by the Contractor

### **3. Safety measures**

Transporter should engage proper vehicles of sound condition with valid Road and dock permit. The driver should be well experience and should poses valid driving license for heavy license . The contract or should take full responsibility towards safety and security of the cargo, container and trailers should follow safety norms for transportation of cargo as stipulated by concerned authorities.

## **GENERAL TERMS AND CONDITIONS**

### **01. Eligibility Criteria for Techno-Commercial Bid**

Those transporters who are registered with Balmer Lawrie & Co Ltd., are alone can participate. Those who are registered with our company are advised to enroll in thee-procurement portal also to view and participate in the tenders.

Tenderers who are not registered with logistics Division, but registered with other Divisions/Locations .of Balmer Lawrie are required to submit the proof of registration / work order copies to consider their offers.

### **02. Submission Of Online Bids**

The bids should be submitted as a Single Bid.

#### **[A] Price Bid**

For Price Bid, only the rates are to be submitted as per the given format.

The entire bid is to have digital signature of the person having Power of Attorney/Power of Authority to sign on behalf of the Bidder.

**B)Tender Opening**

[C] Price Bid will be opened in line with the tender calendar.

**a. Acceptance of offers**

- Balmer Lawrie reserves the right to accept any tender in whole or in part or reject any tender or all tenders or place order for any number of trips/,less than or morethan the tendered trips, with out assigning any reason thereof.
- Bids of any tenderer may be rejected if a conflict of interest is detected between the bidders and Balmer Lawrie at any stage.
- Balmer Lawrie also reserves the right to split the work order between two or more agencies if necessary; such a step shall not form the basis for alteration of rates.
- Balmer Lawrie is not bound to accept the lowest rate for any tender. Balmer Lawrie also reserves its right to allow Public Enterprises (Central / State) price / purchase / contract / service preference as admissible under the existing Government policy. The decision of Balmer Lawrie in this connection will be final.
- Incomplete tenders, conditional tenders, tenders received late or tender not conforming to the terms and conditions mentioned in the Tender documents or will be rejected.
- Wherever conflict of interest arises with thebidder at any stage of the tender process,those tender(s)/bid(s) will be rejected/cancelled. Company's decision in this respect is final and binding.

**b. Negotiations**

- Balmer Lawrie reserves the right to negotiate with the Tenderer. Tenderer will have to attend the concerned office of Balmer Lawrie for negotiations/clarifications required fromthem,inrespectoftheir quotations, without any commitment on the part of BalmerLawrie.
- In case of negotiation, the Tenderer should send the confirmation of outcome of such negotiation writing so as to reach the concerned office of Balmer Lawrie within 3 days from the date of negotiation/ the time stipulated whichever is earlier. If the Tenderer fails to comply with this requirement Balmer Lawrie reserves its right to ignore their revised quotation at its discretion with attendant consequences for the bidder.

**c. Price Variation**

- The price should be firm and irrevocable and not subject to any change whatsoever even due to increase in cost of materials, components and labour cost till thevalidity of the contract period.
- The quoted rates shall be kept valid for acceptance for a period of minimum 30 days from the date of opening the price Bid.

**d. Notification of award**

Prior to the expiration of the period of Bid validity, BL will place purchase order or letter of intent on the successful bidder(s).



**The decision of the company in awarding the Bidders will be final and binding.**

**4) Penalty due to non-performance**

In case of successful bidder failing to honour the terms and conditions of contract, the Company shall be at complete liberty to make alternate arrangements at through L2 bidder or other operators from the open market and any additional cost incurred by the Company in this regard shall be fully recovered from the successful bidder's bills. The Company shall also at liberty to recover in full the charges towards demurrage or detention, if any, imposed by the Company's clients on the Company. In case of any shortage / damage / deterioration / loss of goods for whatever reason, while the same are in the custody of the contractor, the contractor shall be liable to make good the value of goods including duty, penalties and fines as are livable by the appropriate authority for such damage/shortage/loss/deterioration.

In case of damage to the cargo / property, by the contractor's personnel the contractor will be responsible to make good the losses as assessed by the surveyor / shipping line / or any other competent authority within stipulated time failing which the Company or its authorized agency will be free to make good the losses at contractor's 'Risk and Cost', and charges on account of such losses will be fully recovered from Contractor's bills.

**5) Payment Terms**

Payment will be released after 30 days from receipt of Bill along delivery challan / L.R confirming receipt of the cargo.

**6) Sub letting of work**

No part of the contract or any share or interest therein shall in any manner or degree be transferred, assigned or sublet by the contractor directly or indirectly to any person, firm, or corporation without the written consent from the company.

**7) Indemnity**

The Contractor will be required to indemnify and keep indemnified the Company against all losses and claims for injury and damage to any person or any property whatsoever which may arise out of or in consequence of the work and against all claims, demands, proceedings, damages, cost charges and expenses whatsoever that may arise against the company on account of the faults of the contractor/his workmen/due to malfunctioning of the trailers/equipment employed by the contractor.

The company may forward the bidder any such claim/demand or complaint made by any other person against the company. In such event, the contractor shall solely be liable for the disposal of the said complaint.

The contractor will be required to indemnify and absolve the Company of all responsibilities related to employment condition of their employees and should adequately safeguard Company against any possible IR

Problems including those related to employment .The bidder should adhere to all State and Central Enactments related to employment such as Minimum Wages Act, Workmen Compensation Act, Provident Fund Act, Employees State Insurance Act, Gratuity Act, Bonus Act, Contract Labour [Regulations and Abolition] Act etc. Further, Company will not have any liability towards employment, remuneration or compensation in whatever manner made by the bidder to the employees of the bidder. Such demand shall be settled by the bidder directly.

**8) Liability &Ensuring Safety**

The Contractor will be fully responsible for ensuring safety of lives, cargo, vehicles, property in port, while in transit etc. and also within CFS yard. Any damage to any life and/or property while performing the duty for Balmer Lawrie due to negligence/mishandling by the staff / drivers and /or malfunctioning of the trailers would be to the account of the contractor. It is mandatory that necessary 3<sup>rd</sup> party insurance cover is kept valid by the contractor for the vehicle deployed for Balmer Lawrie.

**9) Force Majeure Conditions:**

Delivery schedule is subject to force majeure conditions as under: If at any time during the continuance of this contract, the performance in whole or part by either party of any obligation under this contract shall be prevented or delayed by reasons of any war, hostility, acts of public enemy, civil commotion sabotage, fire,floods, explosions, epidemics, quarantine restrictions, strikes, lock outs or acts of God (hereinafter referred as "events") provided notice of the happening of any such events is given by either party to the other within twenty one days from the date of occurrence thereof, neither party shall by reasons of such event, be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such nonperformance or delay in performance. Performance under the contract shall be resumed as soon as practicable once the "event" come to an end.

**10) Arbitration**

Any dispute or difference arising under this Contract shall be referred for adjudication at Kolkata to a Sole Arbitrator to be appointed by the Chairman & Managing Director, Balmer Lawrie & Co. Ltd. and the provisions of Arbitration and Conciliation Act, 1996 including any statutory modifications or enactment thereof shall apply to the Arbitration proceedings. The fees of the Arbitrator, if any, shall be shared equally by both the parties.
