
- 1) Payment will be released after 30 days from receipt of bill along delivery challan /L.R confirming receipt of the cargo.
- 2) Empty containers have to be deposited at linear nominated plot within 6 days after loading on to trailer at origin point.
- 3) Charges incurred due to late deposit of containers at empty yard, will be the account of transporter.
- 4) Transporter should ensure cargo should be delivered in sound conditions with all safety precautions
- 5) Transporter will be responsible for payments on account of fuel, running, repairs & maintenance, upkeep, insurance, safety, taxes or levy or any penalty for any reason in relation to the vehicle. Drivers of the transporter should hold valid driving licenses. Contractor will be solely responsible to comply with all local & central laws relating to running/ownership of such commercial vehicles and shall arrange inter-state permits in advance at his costs only. all relevant papers of the vehicle such as RTO clearance, fitness, insurance License interstate permits etc., must be available with the vehicle.

- 6) If transporter fails to place the trailer and to effect the movement within reasonable time, the company shall be free to engage any other transporter. The charges being incurred in engaging any other transporter will be recovered at actual from the transporter.
- 7) In case of detention of vehicles due to any lapse on the part of the transporter or its drivers or the owner of the vehicles, no claim for detention charges shall be entertained by the company.
- 8) The transporter should have handled similar jobs in the past for Govt. Dept. / PSUs / reputed corporate customers.
- 9) While transporting the goods, the transporter will strictly adhere to the following principles of safety:
 - a. The driver and cleaner to each vehicle must be available with the convoy during loading, transit & unloading of the consignments.
- 10) In case of any breakdown/detention of the vehicles due to any failure on the part of the transporter, it will be the contractor's responsibility to provide alternative arrangements for contracted transportation at transporter's costs only.
- 11) In case of any loss incurred due to non-delivery/late delivery/ misplacement/damage of the consignment while under the possession of the transporter, the damages claimed by the client are recoverable from the transporter.
- 12) The vendor should compulsorily follow all the provisions of the GST Law, non-compliance of GST Law by transporter will be his sole responsibility and any liability arising due to that has to be borne by transporter.
- 13) Bids of any tenderer may be rejected if a conflict of interest between the bidder and the company is detected at any stage.
