TERMS AND CONDITION

1. The term “**Company (or) BL**” wherever mentioned in the tender document refers to “**BALMER LAWRIE & CO. LTD.**”
2. The term “**bidder**” means the firm or company with whom the order is placed and shall be deemed to include the bidder, successors, representatives, heirs, executors and administrators duly approved by the company.
3. Period of Supply: **Within 45 days from the date of receipt of our Purchase order.**
4. The offer shall be submitted in our enquiry format only and any Conditional offers will be discretion of BLCL.
5. The offer must be kept valid for a minimum period of **45 Days** from the date of opening the offer.
6. The price quoted by the bidder shall remain valid till the supply is completed. During the tenure of the supply period, no price increase will be considered, except for change in statutory levies imposed by Union / State Govt. / Local authorities.
7. **Payment:**
 - a. **95% with full Tax after 15 days from the date of successful replacement of wear plate and PB bushes.**
 - b. **Balance 5% will be kept as retention money against performance guarantee of supplied material and will be released after 90 days on satisfactory performance.**
8. **Penalty Clause:** Any failure on the part of the vendor to supply the material as per the delivery schedule, required quantity, approved quality etc. will be viewed seriously. Further, the company reserves the right to procure the material from the local market at the then prevailing price and the additional cost if any incurred in this process will be recovered from the vendor. Also the vendor may be debarred from participating in future tenders of the company.
9. The bids of any bidder may be rejected if a conflict of interest between the bidder and the Company is detected at any stage.
10. Late tenders / delayed tenders including postal delay and those not conforming to the prescribed terms and conditions will not be considered at all.
11. The company would not carry out any negotiations except with such bidders who is / are the lowest quoted bidders originally. As such it would be in the interest of the bidders to quote the lowest possible rate.
12. Only Registered vendors are eligible to apply. Bids from non-registered vendors are liable to be rejected. Any non- registered vendor interested in supplying the material/service may register with the company and shall be eligible for participation from the next tender onwards
13. It shall be understood that every endeavor has been made to avoid error which may materially affect the basis of the tender and the successful bidder will take upon himself to provide for risk of any error which may subsequently be discovered and shall make no subsequent claim on account thereof.
14. **ARBITRATION:-** Any dispute or difference arising under this Contract shall be referred under jurisdiction of Chennai to a sole arbitrator to be appointed by the Chairman & Managing Director, Balmer Lawrie & Co. Limited and the provisions of Arbitration and Conciliation Act, 1996 including any statutory modifications or enactment thereof shall apply to the Arbitration proceedings. The fees of the arbitrator, if any, shall be shared equally by both the parties. The award shall be a speaking award stating reason therefor and is final and binding

on the parties. The proceeding shall be conducted in English language and courts at Chennai will have exclusive jurisdiction to settle any dispute arising out of this contract.

SCOPE OF JOB

1. Bidders should visit our plant prior to submission of bids and see the machine in person to understand the drawing of the wear plate & PB bush. It is the responsibility of bidders to observe the drawing and accordingly fabricating the wear plate & PB bushes. The bidder should give prior information about their visit to make arrangements to stop the machine to take dimension. The planning should be done on either on Sunday/ holiday.
2. The successful bidder should make correct drawings and the drawing should be handed over to BL during the time of successful replacement.
3. The bushes are being fitted in the pivot on the top arm of the top tool holder. Due to the deep worn out of the bush, the body of the top arm pivot also got worn out and the same has to be metal deposited with proper grade of material and to be machined properly which is the responsibility of successful bidder.
4. The successful bidder should do the replacement of wear plate & PB bushes in the machine by his own. However, other assistance like providing power, if required manpower assistance and available normal type of tools will be provided by BL.
5. The replacement job should be carried out within 15 days from the date of receipt of material at BL stores. It is responsibility of BL and successful bidder.
6. The replacement job should be completed within 2 days time frame in order to release the machine from production schedule.
7. The replacement job will be planned on Sundays/ Holidays only to avoid the production loss.
