## **6. ACCEPTANCE**

## **7. VALIDITY OF OFFER**

Rates offered against this tender shall be valid for 6 MONTHS from the date of opening of tender. Further if required the same Tender can be extended to further 6 months subject to mutual acceptance at both end with same terms and conditions.

## **8. PLACEMENT OF TRANSPORT, HANDLING EQUIPMENT & LABOUR**

The contractor/transporter should arrange pick up from the pickup point to the nominated place immediately upon receipt of information from the authorized person of this office. Soft or Hard copy of the documents related to the movement will be provided by this office to the contractor/transporter. In case, if the contractor/transporter unable to provide the required Transportation, labour & Handling Equipments for unloading and loading, charges if any due to delay, detention will be passed on to contractor/transporter.

The contractor/transporter should be ready to make available required type of Handling Equipment, Transport and Labour on any day as demanded by us. No transshipment of goods is allowed unless specifically instructed in writing by us.

Tenderer will be responsible for any deviation on their part and they would be responsible for all risks and damages that may arise due to negligence.

The Successful tenderer should ensure the safety of cargo which they are entrusted to carry. The contractor /transporter shall ensure that the materials handled carefully at loading

## **9. PAYMENT**

Upon Successful completion of the Job entrusted contractor/transporter can submit Bill for transportation; Bill shall be accompanied by the necessary acknowledgements confirming the receipt of cargo in good condition. Payment will be done within 21 days from the date of receipt of your Bill.

## **10. NON AVAILABILITY OF VEHICLE, HANDLING EQUIPMENT & LABOUR**

If the contractor/transporter fails to place the Transport, Labour & Handling equipments within reasonable time, the company shall be free to engage any other Contractor.. The charges being incurred in engaging any other Contractor will be recovered at actual from the contractor/transporter.

## **11. TERMINATION OF CONTRACT**

In case the Company finds the performance of the contractor not meeting the contractual commitments, the company reserves the right to terminate the contract without assigning any reasons and without giving any notice.

## **12. SAFETY**

The Successful tenderer should ensure the safety of cargo which they are entrusted to carry. The contractor /transporter shall ensure that the materials transported are not damaged and handled carefully till it reaches the designated place of delivery.

The contractor should comply with the provisions of Motor Vehicles Act in respect of the vehicles engaging for the movement.

The transporter shall be liable for the damage or any other shortage including the cost of repairing due to the negligence of transporter. The contractor / transporter shall abide by all traffic and labour laws and Motor vehicles Act which is in force.

## **13. CLAIMS**

All Claims and consequential losses arising out of the delay, detention, damage, loss in/during transportation should be settled immediately and shall be paid by the contractor/ transporter or it will be recovered from their dues.

## **14. TYPE OF TRANSPORT, LABOUR & HANDLING EQUIPMENT**

The contractor/transporter should provide LCV Trucks, Labour & Hydraulic Trolley as

mentioned above.

## **15. JURISDICTION**

All disputes or differences arising under, out of, or in connection with, the contract Shall be subject to exclusive jurisdiction of the relevant to the Honorable Court of Madras.

## **16. APPOINTMENT OF CONTRACTOR/TRANSPORTER**

The company reserves its right to accept or reject any or all the tenders, without assigning any reasons whatsoever. In the event of any dispute, the company's decision shall be final.

controlled and or avoided with reasonable diligence.

## 20. ARBITRATION

Any dispute or difference arising under this contract shall be referred for adjudication at Calcutta to a sole arbitrator to be appointed by the Managing Director of Balmer Lawrie & Co .Limited., and the provision of Arbitration and Conciliation Act, 1996 including any statutory modifications or enactment thereof shall apply to the Arbitration proceedings. The fees of the arbitrator, if any shall be paid equally by both parties.
