# SCOPE OF WORK

The Scope of Work of this tender consists of providing material, equipment, machinery, labour, transport, tools & tackles, required services etc. for the above mentioned subject works at CFS, Kolkata as described in BOQ specifications, General Terms & Conditions and as mentioned elsewhere in this tender.

Work covered in this tender document shall generally be as detailed herein below. However, the contractor shall be responsible to complete the work in all respects and in doing so, provide/ supply all the facilities/ materials/ services which may have not be explicitly covered below, but nevertheless are required to complete the work envisaged, with the exception of only such items as have been specifically excluded from contractor's scope.

- 1. Cleaning of the cracked portion of Linde Spreader
- 2. Gouging of the cracked portion
- 3. Machining & Metal Fit of the cracked portion
- 4. Machining of total new work material MIG wire
- 5. Required CO2 cylinder, O2 cylinder, LPG cylinder, Gascutter set, MIG welding set etc. to be arranged accordingly
- 6. Load Testing and Certification by Competent authority, post execution of the said Repair works

#### **GENERAL TERMS AND CONDITIONS**

- 1. Eligibility Criteria For Techno-Commercial Bid
- a. Bid Security Declaration. EMD Not applicable.. Bidder have to submit "Bid Security Declaration" stating that if the bidder
  - Withdraws the offer during validity period of the offerNon acceptance of order by the bidder within the stipulated time after placement of order.
  - Any unilateral revision made by the bidder during the validity period of the offer.

- Non submission of Security Deposit
- Bidders submitting false/fabricated/bogus documents in support of their credentials
- then the bidder will be put on banned list for 1 year and will not be able to participate in any tender for that period. The declaration is to be given on the letter head of the bidder.(Annexure A)
- b. Registration Certification with GST.
- c. The bidder should not have been black listed in any of the PSU's or private organizations and a selfcertification to this affect would need to be provided.

#### 2. Submission Of Online Bids

The bids should be submitted in the form of a single bid consisting of both qualification documents and price in our e-procurement website. The entire bid is to have digital signature of the person having Power of Attorney/Power of Authority to sign on behalf of the Bidder

#### 3. Tender Opening

Tender will be opened as per the tender calendar

#### 4. Acceptance of offers

4.1 Balmer Lawrie reserves the right to accept any tender in whole or in part or reject any tender or all tenders or place order for any quantity, less than or more than the tendered quantity, without assigning any reason thereof.

Bids of any tenderer may be rejected if a conflict of interest is detected between the bidders and Balmer Lawrie at any stage.

4.3. Balmer Lawrie also reserves its right to allow Public Enterprises (Central / State) price / purchase / contract / service preference as admissible under the existing Government policy. The decision of Balmer Lawrie in this connection will be final.

4.4 Incomplete tenders, conditional tenders, tenders received late or tender not conforming to the terms and conditions mentioned in the Tender documents or not accompanied by the requisite Bid Seurity Declaration (unless exempted under the terms of this Tender) will be rejected.

#### 5. Notification of Award

Prior to the expiration of the period of Bid validity, BL will place purchase/work order or letter of intent on the successful bidder(s). Balmer Lawrie

Balmer Lawrie reserves the right to negotiate with the L1 Tenderer only. Tenderer will have to attend the concerned office of Balmer Lawrie for negotiations/clarifications required from them, in respect of their quotations, without any commitment on the part of Balmer Lawrie.

In case of negotiation, the Tenderer should send the confirmation of outcome of such negotiation in writing so as to reach the concerned office of Balmer Lawrie within 3 days from the date of negotiation/ the time stipulated whichever is earlier. If the Tenderer fails to comply with this requirement Balmer Lawrie reserves its right to ignore their quotation at its discretion and proceed to finalise the tender.

#### 6. Validity of offer

The rate Offer should be kept valid for acceptance for 10 days from the last date for submission of the tender. The rates once submitted shall not be changed/varied/added/altered during this period.

#### 7. Award of Contract

The contract will be awarded based on L1 rate for the overall job.

#### 8. Payment Terms

Payment will be made within 30 days from the date of submission of bills provided the same are correct in all respect and certified by authorised representative of the Company. Appropriate tax [if applicable] like Income tax, Works contract tax and statutory charges, if any will be deducted from the bills as per statutory regulations.

#### 9. RATES, TAXES & DUTIES

(a) The tenderer should quote for all items in the Price Bid. The rates should be expressed in English both in figures and words. Where discrepancy exists between the two, the rates expressed in words will prevail. Similarly if there is any discrepancy between unit rate and total amount, the unit rate will prevail.

(b) The rates should be quoted in the same units as mentioned in the tender schedule of quantities online.

# 10. Contract Period

The contract would be for a period of 30 days from the date of issuance Work Order/ LOI whichever is earlier.

#### **11. Penalty:** Vendor shall be liable to pay liquidated damages/penalty for the following:

If any damage is caused to the property and/or machinery (including its any part) of Balmer Lawrie& Co Ltd., directly and/or indirectly incidental to and connected with the execution of the work, the loss shall be assessed by BL and vendor shall be liable to indemnify the value of such damaged property and/or machinery.

BL shall have the right to employ any other agency to complete the remaining work at the risk and cost of the Contractor, in the event of his failing to complete the work within the stipulated time and as per the instruction of authorized personnel of Balmer Lawrie CFS Kolkata.

#### 12.Termination:

#### 12.1 Termination on expiry of the CONTRACT

This Agreement shall be deemed to have been automatically terminated on the expiry of the CONTRACT period unless the BL has exercised its option to extend this CONTRACT in accordance with the provisions, if any, of this CONTRACT.

#### 12.2 Termination on account of insolvency

In the event the CONTRACTOR or its collaborator at any time during the term of this Agreement becomes insolvent or makes a voluntary assignment of its assets for the benefit of creditors or is adjudged bankrupt, then the BL shall, by a notice in Writing have the right to terminate this CONTRACT and all the CONTRACTOR's rights and privileges hereunder, shall stand terminated forthwith.

# 12.3 Termination for unsatisfactory performance

If the BL considers that the performance of the CONTRACTOR is unsatisfactory or, not up to the expected standard, the BL shall notify the CONTRACTOR in writing and specify in detail the cause of such dissatisfaction. The BL shall have the option to terminate this Agreement by giving 10 days' notice in writing to the CONTRACTOR, if, CONTRACTOR fails to comply with the requisitions contained in the said written notice issued by the BL.

# 12.4 Consequences of termination

In all cases of termination herein set forth, the obligation of the BL to pay shall be limited to the period up to the date of termination. Notwithstanding the termination of this Agreement, the parties shall continue to be bound by the provisions of this Agreement that reasonably require some action or forbearance after such termination.

# 13.Security Deposit/ Performance Bank Guarantee

(i)The successful bidder shall deposit an amount of 3% of the total contract value within seven days from the date of Letter of Intent (LOI)/Work order whichever is by way of Demand Draft in favour of BALMER LAWRIE & CO. LTD. payable at Kolkata as Security deposit/Performance Bank Guarantee. Bank Guarantee in the prescribed format, issued by Scheduled Commercial Bank can also be accepted by the company in lieu of the deposit. The security deposit will be refunded after 12 months of successful completion of contract period.

(ii) If Contractor fails to provide the Security Deposit within the period specified, such failure will constitute a breach of the Contract and Balmer Lawrie shall be entitled to award the Work elsewhere at Contractor's risk and cost.

The Security Deposit shall be released to the contractor after completion of work, final bill payment & after submission of Performance Bank Guarantee covering the defect liability period which will be for a period of one year from the date of completion of job certified by Balmer lawrie's Engineer In-Charge.

(iii) No interest shall be payable against Security Deposit.

(iv) The Security Deposit / Retention Money shall remain at the entire disposal of BL as a security for satisfactory execution and completion of the Work(s). BL shall be at liberty to deduct and appropriate from the Security Deposit / Retention Money such damages (liquidated, penalty or otherwise) and other dues and recoveries from Contractor under this Contract and the amount by which Security Deposit / Retention Money is reduced by such appropriations, will be made by further deductions from Contractor's subsequent bills to that extent as to make up the Security Deposit / Retention Money.

(v) Security deposit has to be paid by MSE vendors too.

Balmer Lawrie reserves the right to appoint any other contractor on same or similar terms and conditions or otherwise to render the same or similar services utilize the services of other contractor at the RISK & COST of the contractor and to recover the charges and expenses incurred in excess of the contractual rates, terms & conditions from the contractor. This will be without prejudice to the rights of Balmer Lawrie for any other action including termination of contract, forfeiture of security deposit etc.

The Security Deposit is liable to be forfeited or appropriated towards any penalty imposed by BL as a result of acts of omission/commission/gross negligence on the part of the contractor or towards any charges like demurrage, damage to the container/cargo that may become payable by Balmer Lawrie to its customers or failure of the successful bidder to execute the work as per terms and conditions of the contract without prejudice to the other right or action that the Company is entitled to. The Security Deposit after adjustment, if any, may be refunded to the contractor after successful completion of the contract and after settlement of all dues.

This is a no split tender for MSE bidders.

#### 14. Force Majeure Conditions:

Any delay in or failure of the performance of either part hereto shall not constitute default hereunder or give rise to any claims for damage, if any, to the extent such delays failure of performance is caused by occurrences such as Acts of God or an enemy, expropriation or confiscation of facilities by Government authorities, acts of war, rebellion, sabotage or fires, floods, explosions, riots, or strikes. The Vendor shall keep records of the circumstances referred to above and bring these to the notice of the Balmer Lawrie CFS Kolkata authorized personnel in writing immediately on such occurrences. The amount of time, if any, lost on any of these counts shall not be counted for the delivery period. On decision of BL/BL arrived at after consultation with the Vendor, shall be final and binding. Such a determined period of time be extended by the BL to enable the Vendor to deliver the items within such extended period of time.

If Vendor is prevented or delayed from the performing any of its obligations under this agreement by Force Majeure, then Vendor shall notify BL the circumstances constituting the Force Majeure and the obligations performance of which is thereby delayed or prevented, within seven days of the occurrence of the event.

# 15. Arbitration

Any dispute or difference arising under this Contract shall be referred under jurisdiction of Kolkata to a sole arbitrator to be appointed by the Chairman & Managing Director, Balmer Lawrie & Co. Ltd. and the provisions of Arbitration Act, 1996 including any statutory modifications or enactment thereof shall apply to the Arbitration proceedings. The fees of the arbitrator, if any, shall be shared equally by both the parties. The award shall be a speaking award stating reason therefor and is final & binding on the parties. The proceeding shall be conducted in English language and courts at Kolkata will have exclusive jurisdiction to settle any dispute arising out of this contract.

#### **16. Alternative Arrangement**

# TENDER NO: BL/CFS\_KOL/ Repair Work-Linde Spreader Crack/21-22/20

In absence of the timely and proper performance by the contractor, BL reserves the right to utilize the services of any other contractor without notice at the risk and cost of the contractor and to recover charges and expenses in excess of the contractual terms from the contractor. Similarly if the contractor fails to meet their contractual obligations, the work shall be completed at their risk and cost through alternative sources/arrangements. This will be without prejudice to the rights of BL for any other action including termination, forfeiture of security deposit etc.

**17. LIMITATION OF LIABILITY:** The Contractor will be fully responsible for ensuring safety of person/ lives, plant, machinery, assets, vehicles, property, cargo and containers within BL CFS-Kolkata premises, where jobs under scope of this contract are being carried out by them. Any damage to any life and/or property therein as mentioned due to negligence/mishandling during the execution of the said subject works by the Contractor, would be on the account of the Contractor. It is mandatory that necessary 3rd party insurance cover is kept valid by the Contractor under this contract.

**18.** The Contractor should take necessary insurance, but not limited to third party liability. It is further clarified that in case of any accident during the execution of said subject works, the Contractor shall be liable to BL or any third party for any loss/damage to person/ lives, plant, machinery, assets, vehicles, property, cargo and containers within BL CFS-Kolkata premises. A copy of such policy is required to be provided to BL CFS-Kolkata.

19. Tender for registered approved vendors only: The Responses/offer from registered/approved vendors alone will be accepted and that other interested vendors have to register with the unit (Container Freight Station, Kolkata) and subject to such registration being confirmed, they would be considered for the subsequent Tenders.
